The one thousand two hundred forty-third meeting of the Council of the City of Milwaukie, Oregon, was held on the 5th day of May, 1975, with the following councilpersons present:

The invocation was given by the Reverend T. R. Buzzard - Milwaukie Emmanuel United Methodist Church, and the pledge of allegiance was recited.

CONSENT CALENDAR

Councilwoman Burgess requested that items d, e and g be removed for discussion, and Councilman Hutchison requested that items b and f be removed for discussion.

- b) Council has received copy of letter from Senator Hatfield, dated April 25, 1975, concerning Community Development Block Grant funds.
 - c) Council has received memorandum from Public Works Director, dated April 21, 1975, recommending payment of retainage to Riverside Construction, Inc., for pumping stations, Sewer Construction Schedule V, East Milwaukie - Island Station L. I. D.
 - d) Chico's Pizza has made application for liquor license renewal.
 - e) Council has received copy of Manager's letter of April 22, 1975, to County Public Health Officer, concerning a raw sewage health hazard in a vacant area southerly of the Tarrybrooks subdivision, and a copy of reply from County Health Department, dated April 29.
 - f) Council has received copy of letter from Congressman Duncan, dated April 16, 1975, concerning Community Development Block Grants.
 - g) Council has received memorandum from Public Works Director, dated May 1, 1975, requesting Council acceptance of Mallard Lake Way in Omark Industrial Park. This dedication has been recommended by the Planning Commission.
- It was MOVED by Burgess, SECONDED by Hutchison, to accept the consent calendar, items a through g. MOTION CARRIED and so ordered.

AUDIENCE PARTICIPATION

1. Mayor Hupp read proclamation naming May 15, 16 and 17 as Poppy Days, and May as Poppy Month, and Laurie Calhoun, American Legion Miss Poppy, recited a poem.
2. Arnold Callan, 11912 SE Wood Avenue, complimented the Council on giving consideration to citizens who appear before the Council, but said if the Council revives the downtown

improvement plan, it would be against the wishes of the people. He also appealed for something to be done for senior citizens on low incomes, and suggested a study committee be appointed. He presented petitions signed by "scores of the elderly," asking that the Council do something about the "suggested exorbitant sewer assessment." Mr. Callan also praised the city for passing the motorcycle ordinance.

CORRESPONDENCE

1. Council has received letter from Irwin Adams, dated April 29, petitioning the Council to reinstitute the Downtown Improvement Plan in conformity with the Comprehensive Plan as adopted by the Council. Mr. Adams stated he was speaking for several members of the Milwaukie Downtown Improvement Study Committee.

Councilwoman Burgess suggested the letter does not give sufficient information.

Dr. Lawrence Dennis, 2215 Harrison, suggested the committee is asking for a blank check to reestablish the L. I. D.

2. Council has received a petition signed by 14 persons, asking that some consideration be given to people on fixed incomes in regard to sewage assessment and other expenses of the community.

DEFERRED SEWER ASSESSMENTS - DEFERRED HOOK-UP FEE - REDUCED UTILITY RATES

There was a discussion of setting a work session on the above subjects. City Attorney is to research whether it is possible to withdraw from Bancroft bonding of sewer assessments. The work session will be held on May 28, 1975.

CORRESPONDENCE

3. Council has received copy of letter from Riverfront Development Committee, requesting \$15,000 to \$25,000 to be used in engaging planning consultant assistance in connection with riverfront development planning. The letter will be referred to the Budget Committee.

REPORT ON FIRE DEPARTMENT SICK LEAVE RATE AND SICK LEAVE LINE ITEM

Council has received report from Fire Chief, dated May 1, on the department sick leave rate, and memorandum from Finance Director, dated May 1, explaining overexpenditure of the department sick leave line item.

It was MOVED by Burgess, SECONDED by Swan, that Resolution Number 13-1975 (A RESOLUTION PROVIDING FOR THE INVESTMENT OF MUNICIPAL FUNDS) be read. MOTION CARRIED and so ordered. It was MOVED by Burgess, SECONDED by Swan, that Resolution 13-1975 be adopted.

OTHER BUSINESS

1. Council has received copy of letter from State Highway Division, dated May 1, 1975, re audit citations on Furnberg Park. The Bureau of Outdoor Recreation audit report states the property was acquired before BOR approval was granted. A meeting will be held with Highway Division personnel to discuss the matter.
2. Council has received copy of letter from Senator Packwood regarding a bill in Congress which would provide additional funds for Community Development Block Grants.
3. Council has received copy of letter from State Executive Department Intergovernmental Relations Division, dated May 1, 1975, regarding Milwaukie's application for 701 planning funds.
4. Manager was asked to write to the Crossen and Bailey families to express the Council's sympathy for the loss of their sons by drowning.

APPOINTMENT TO BUILDING CODE BOARD OF APPEALS

Council has received letter from J. Wayne Daigle, Building Official, recommending appointment of George Korum to fill vacancy created by resignation of Bob Turk on the Building Code Board of Appeals. Mayor appointed Mr. Korum to the Board.

FRANKO OIL - SUIT AGAINST CITY

City's Motion to Quash has been allowed in the above case, and petitioners have 15 days to apply for a new writ.

EXECUTIVE SESSION

Council went into executive session at 9:20 p. m. to discuss bargaining with employee groups.

Council returned to regular session at 10:05 p. m.

OTHER BUSINESS

1. Donald Fenton, 2306 SE River Road, discussed a billing for gravel purchased from the city and distributed on street right-of-way not now required for public use. The resolution was that while Mr. Fenton had willingly encumbered the cost of the gravel for a public street, subsequent use by the city sewer contractor of the street improved at Mr. Fenton's expense had decimated the gravel he purchased, and it was felt, upon recommendation of the Manager, that the city bear the cost of the gravel in this special case.
2. Mayor asked why the cost of sidewalk improvements on the "Gay Blade block" had not been assessed to the property owners.
3. Council has been invited to a riverboat tour of the Willamette as guests of the Port of Portland, at noon on May 10.
4. Council has received letter from Senator Walter F. Brown, asking for support of House Bill 2885, a tax on property resold in less than six years from the date of purchase, and his amendments to the bill which would return funds to Oregon cities and counties. It was suggested if a letter is written, the bill be opposed, but if it does pass, it should be with Senator Brown's amendments.
5. Councilman Hutchison gave staff a copy of DEQ noise control regulations.
6. Councilman Englund asked that any future amendments to Building Code follow the procedure spelled out in the Building Code.

PAYMENT OF BILLS


It was MOVED by Burgess, SECONDED by Swan, that the bills listed for May 6, 1975 payment be approved for payment.
