You name it, they've got it

"Anybody who buys books anywhere else is nuts."

That's how Dorie Crooks, who is the fill-in manager of The Pond House Used Book Store, responds when describing the quality, variety, and price of the store's selection.



All of the sale items are of gift-quality - not library rejects, as Dorie puts it - and are incredibly affordable. Harcovers are \$2, paperbacks .50, CD's and records are \$1 and comic books are .25. Dorie, Manager Mary Carole Potter, and a team of other volunteers operate the book store located at 2215 SE Harrison, and they choose to dedicate their time there because every penny spent at the store goes to The Friends of the Ledding Library. The Friends support programs for children and adults and help the library purchase special equipment and materials that otherwise could not be afforded.

The small lodge-like shop is open on Fridays and Saturdays from 11 a.m. to 4 p.m. and is neatly organized and packed with books, magazines, records and books-on-tape of all kinds.

"We have just about anything you could think of," explains Carol Kay, the president of The Friends.

Every child who visits the store gets a free book on every visit and new materials are donated almost every day, so its worth regularly revisiting the Store.

Utility billing moves to monthly schedule

Beginning in January the City will change the way it bills its utility customers.

The changes **will not** result in any rate increase.

Customers will start receiving a bill every month, rather than every other month. This change is intended to make budgeting more manageable. Also, payments will now be due by the 10th of the month and the practice of providing a 15-day "grace period"

will be discontinued.

For those customers who do not make their payment on time, a past due notice will be mailed and will be charged a \$5 late fee, instead of the previous \$10 fee.

Shut-off notices will be mailed if payment is not received by the date indicated on the

past due notice. Another \$5 late fee will be charged, down from

Land Use gets a tune-up

Have you ever received a notice in the mail about the school down the street wanting to expand or your neighbor wanting to divide their property? These are just some of the ways that the City involves the public in the land use and development review process. This process is meant to provide fair and timely review of development proposals, allow for meaningful public involvement, and facilitate quality development.

Over the past year, the City has been preparing code amendments to update and improve the City's review process. These amendments involve substantial changes to the Zoning Code. You may want to learn more about this project if you've ever wondered:

How to appeal a land use decision in your Neighborhood.

What it would take to get a variance for your home addition.

What you can do if your house doesn't comply with current height or setback standards.

Changes to the Zoning Code require review by the Planning Commission and adoption by City Council at public hearings. The first hearing on the proposed amendments is currently scheduled for January 25, 2011.

Service shut-off will occur if payment is not received by the date and time indicated on the shut-off notice and an additional \$30 fee bill be charged. The new shut-off date has been increased to

Pair of Light Rail meetings to focus on design, safety

Milwaukie's Design and Landmarks Committee will host the January Monthly Light Rail Meeting where discussion will focus on the design elements of the future alignment and station area.

The meeting will be held on Wed, Jan. 26th 6:30 p.m. in the Public Safety Building and the public is strongly encouraged to join the conversation.

Although the alignment from Portland to Milwaukie isn't expected to open until 2015, it's in this year when the design will be drawn. The

design discussion with the Design and Landmarks Committee members and community members in attendance will inform what the alignment looks like in Milwaukie.

The primary agenda item of Milwaukie's Public Safety Advisory Committee Jan. 27th meeting is safety and security of the future alignment.

Representatives from TriMet will be on hand to talk about the measures that are being taken during this design phase and those that

will be implemented during operation to ensure the line is safe. The meeting will also be held in the Public Safety Building, and begin at 6:15 p.m.

As winter approaches here in the Northwest, so do the winter driving conditions that can make driving hazardous. Here are a few tips from ODOT:

- Use antifreeze that's good to -25F°
- Keep wipers clean and in good condition
- Fill the windshield washer tank
- Test all lights and carry spare bulbs
- Ensure the heater and defroster are working properly
- Make certain your battery is fully charged and cables are not loose
- Ensure your tires are in good condition and properly inflated for best traction, including your spare
- Carry chains or use traction tires in winter
- Keep an automotive safety kit in your vehicle
- Be aware that in Oregon studded tires are legal Nov. 1 through March 31

WHAT IS CERT?

COMMUNITY EMERGENCY RESPONSE TEAM

CERT training focuses on increasing the level of SAFETY for those individuals who will be stepping forward to assist after a disaster. CERT promotes a partnership between emergency services and the community members they serve.

In the wake of a disaster, emergency personnel and their resources may be overwhelmed by the response needs in the community. CERT training gives individuals a glimpse into the 'System' designed to save lives in the most efficient and effective manner possible.

The training is available for all citizens who are interested in disaster and emergency preparedness.

Cost for class is \$25 (payable to CCFD#1) and covers your manual and training. Manual must be studied prior to class – give yourself several days time to study.

You need to bring your own lunch, dress in layers, and get plenty of sleep the night before! You will be provided with your manual or DVD once you've registered.



CLASS SESSION TOPICS

The basic CERT course covers Disaster Preparedness, Disaster First Aid, Fire Prevention and Suppression, Light Search and Rescue and Disaster Psychology. The training will also include hands on skill training for participants.

Students will receive additional opportunities to become a part of the Milwaukie CERT team and receive additional skill training while being prepared to assist your community when needed.

POWER OUTAGES CAN BE MORE THAN INCONVENIENT

At times during the winter, you will experience a power outage. If the power goes out during cold weather, the temperature inside your home can drop rapidly. Take these simple precautions to stay warm and safe during a winter power outage:

Prepare for the outage:

- If you have a fireplace or woodstove, stock up on firewood.
- Have extra food at home.
- Get plenty of flashlights.
- Have an emergency radio to hear about what is going on.
- Keep any medical supplies you will need.
- Fill up containers of water to have something to drink just in case you run out of water.


During an outage:

- Keep warm by wearing loose layers of clothing to trap body heat and save body heat by wearing a hat, even while sleeping.
- Pick one room and close it off to keep the heat in.
- Unplug all sensitive electronic equipment, including TV's, stereo, VCR, microwave oven, computer, cordless telephone, answering machine and garage door opener to prevent damage from a power surge when power is restored.
- Never use charcoal or gas barbecues, camping heating equipment, or home generators indoors. They give off carbon monoxide which can be deadly.
- Also, remember to check on elderly neighbors or neighbors that may need assistance to make sure they're equipped with enough supplies to keep warm.

COMMUNITY DISASTER SHELTER LOCATIONS

Six community disaster shelter locations have been secured throughout the City. These facilities may be open to provide a gathering place or temporary shelter and safety, depending on the emergency event. These spaces are recommended for residents unable to shelter at home, at a neighbor's or close-by relatives, or are unable to listen to emergency broadcasts for the locations of designated Red Cross shelter sites. Neighbors should be prepared to take sleeping, food and water supplies with them to the shelter. Pets may not be allowed.

WINTER STORMS - DECEPTIVE KILLERS

Winter storms are considered deceptive killers because most deaths are indirectly related to the storm.

- **Automobile or other transportation accidents:** This is the leading cause of death during winter storms.
- **Exhaustion and heart attacks:** Caused by overexertion, these are the two most likely causes of winter storm-related deaths.
- **Hypothermia and asphyxiation:** Elderly people account for the largest percentage of hypothermia victims. Many older Americans literally freeze to death in their own homes after being exposed to dangerously cold indoor temperatures, or they are asphyxiated because of improper use of fuels such as charcoal briquettes, which produce carbon monoxide.
- **House fires:** These occur more frequently in the winter because of the lack of proper safety precautions when using alternate heating sources (unattended fires, disposal of ashes too soon, improperly placed space heaters, etc.). Fire during winter storms presents a great danger because water supplies may freeze, and it may be difficult for firefighting equipment to get to the fire.

BE PREPARED TO WEATHER THE STORM

While many of you may be prepared for emergencies, take some time to thoroughly check and update your family's disaster supply kit. In addition to a good supply of food (for humans and pets), water, good flashlights and plenty of batteries, having the following items easily accessible can help you weather the storm:

- A shovel to keep your home accessible when there is snow, ice or piles from plowing on sidewalks, walkways and driveways
- Traction aids for your car and feet - sand, gravel, or kitty litter as well as good snow/warm shoes or traction devices to clip on your shoes
- Chains, snow tires that has plenty of gas; or use TriMet
- An alternative heat source or dry wood for the fireplace (with a clean fireplace and chimney)
- Prescription medications and necessary over-the-counter items

5 TIPS FOR SAFE WINTER TRAVEL


Travel might be on your agenda over the next few months, whether its skiing at the mountain or heading to grandma's house for the holidays.

Arrive safely at your destination by following these recommendations:

- Before you go, visit www.TripCheck.com or call 5-1-1 for the latest in road conditions, weather forecast, chain requirements, and incident information.
- Let someone know your destination, your route, and when you expect to arrive. If your car gets stuck along the way, help can be sent along your predetermined route.
- Check in when you've reached your destination.
- Don't use cruise control in wet, icy or snowy weather.
- Keep your car's gas tank full for emergency use and to help prevent the fuel line from freezing.
- Put together a separate disaster supplies kit for the trunk of each car used by members of your household.

If you should become stranded during a winter storm, these items will make you more comfortable until the storm passes.

- In addition to basic vehicle safety items – properly inflated spare tire, wheel wrench, jack, jumper cables, tool kit, flashlight and extra batteries, reflective triangle, signal flares, duct tape - you should always keep a first aid kit and emergency supplies.
- During winter, make sure your vehicle has items such as a windshield scraper and snow brush, salt, sand, shovel, tire chains, and warm clothing.
