

ORDINANCE NUMBER 1181

AN ORDINANCE ANNEXING CERTAIN TERRITORY CONTIGUOUS TO THE PRESENT BOUNDARY OF THE CITY OF MILWAUKIE, CLACKAMAS COUNTY, OREGON, AND FIXING THE EFFECTIVE DATE OF SUCH ANNEXATION.

THE CITY OF MILWAUKIE DOES ORDAIN AS FOLLOWS:

Section 1. The City of Milwaukie, Oregon, having heretofore by Ordinance Number 1177, duly passed by the Council of the City of Milwaukie, Oregon, on the 26th day of August, 1968, dispensed with submitting the question of the annexation of the territory therein described, to the registered voters of the City of Milwaukie, Oregon, and having heretofore, by said ordinance, fixed the 23rd day of September, 1968, as the day for a hearing at which time the registered voters of said city might appear and be heard on the question of said annexation, and all required notices relating to such hearing having heretofore been published and posted as required by the provisions of Section 222.210, Oregon Revised Statutes, and a public hearing having been had by the Council of the City of Milwaukie, Oregon, pursuant to such notices, and no registered voters of the City of Milwaukie, Oregon, appearing at said hearing who protested said annexation, and Delmar H. McClure and Jocelyn D. McClure, husband and wife, the sole owners of record of the territory to be annexed, having heretofore, on the 8th day of July, 1968, given and filed their consents to said annexation, to and with the City Council of the City of Milwaukie, Oregon,

IT IS HEREBY DECLARED AND PROCLAIMED THAT THE FOLLOWING DESCRIBED TERRITORY, SITUATED IN THE COUNTY OF CLACKAMAS AND STATE OF OREGON, to-wit:

The West 60.00 feet from the following described property:
The South 16.21 feet of Lot 9 and all of Lot 10, EXCEPT the South 95.00 feet thereof, in GIBSON'S SUBDIVISION OF TRACTS 10, 11, 12 and 13 and the West 480.00 feet of Tracts 1 and 2 of the Logus Tracts, County of Clackamas and State of Oregon.

The West 60.00 feet of the following described property:
The North 55 feet of the South 71.21 feet of Lot 9, GIBSON'S SUBDIVISION OF TRACTS NUMBERED 10, 11, 12 and 13, and the West 480 feet of Tracts 1 and 2, of THE LOGUS TRACTS, in the County of Clackamas and State of Oregon, as recorded in Volume 7, page 47, Plat Records,

which property is contiguous to the present boundary of the City of Milwaukie, Oregon, BE AND THE SAME IS HEREBY ANNEXED TO THE CITY OF MILWAUKIE, CLACKAMAS COUNTY, OREGON.

Section 2. The City Recorder of the City of Milwaukie, Oregon, is hereby directed to make and submit to the Secretary of State

of the State of Oregon a copy of this ordinance, a copy of the written consent of the owners of the territory annexed and a copy of the ordinance of the City of Milwaukie, Oregon, being Ordinance number 1177, declaring that no election is required in said city, and to transmit further copies of said documents to the County Assessor, the County Clerk and the County Surveyor of the County of Clackamas, Oregon.

Section 3. The effective date of the annexation hereinabove declared and proclaimed shall be the date upon which the documents referred to in Section 2 of this ordinance shall have been filed with the Secretary of State, State of Oregon.

Read the first time this 23rd day of September, 1968.

Read the second time and passed unanimously by the Council this 23rd day of September, 1968.
