

ORDINANCE NUMBER 1022

AN ORDINANCE ANNEXING CERTAIN TERRITORIES, CONTIGUOUS TO THE PRESENT BOUNDARIES OF THE CITY OF MILWAUKIE, CLACKAMAS COUNTY, OREGON, AND FIXING THE EFFECTIVE DATE OF SUCH ANNEXATION.

THE CITY OF MILWAUKIE DOES ORDAIN AS FOLLOWS:

SECTION 1. The City of Milwaukie, Oregon, having heretofore by Ordinance Number 1022, duly passed by the Council of the City of Milwaukie, Oregon, on the 8th day of June, 1964, dispensed with submitting the question of the annexation of the territories therein described, to the registered voters of the City of Milwaukie, Oregon, and having heretofore, by said Ordinance, fixed the 29th day of June, 1964, as the day for a hearing at which the registered voters of said City might appear and be heard on the question of said annexation before it, and all required notices relating to such hearing having heretofore been published and posted as required by the provisions of Section 222.210 Oregon Revised Statutes, and a public hearing having been had by the Council of the City of Milwaukie, Oregon, pursuant to such notices, and no registered voters of the City of Milwaukie, Oregon, appearing at said hearing who protested said annexation, and HATTIE A. FOSTER, a widow; EUGENE K. CAHILL and DOROTHY A. CAHILL, husband and wife, THE SOLE OWNERS OF RECORD of the territories to be annexed, having heretofore, between the date of June 1, 1964, given and filed their consents to said annexation, to and with the City Council of the City of Milwaukie, Oregon, IT IS HEREBY DECLARED AND PROCLAIMED that the following described territories, situate in the County of Clackamas and State of Oregon, to-wit;

(TAX LOT 64, GEORGE WILLS D.L.C.) (part of)

Beginning at a point that is S 83°48' E. 653.34 feet and S. 3°30' E. 107.04 feet from the Northwest corner of Section 30, T. 1 S., R. 2 E., W.M. Clackamas County, Oregon; thence S. 83°48' E. 166.43 feet; thence S. 8°24' W. 137.10 feet to a point of curve to the right a distance of 47.84 feet more or less to the most easterly corner of a tract described in Book 499 at page 113, Deed Records; thence N. 40° 09'10" W. along the North line of said Tract a distance of 69.80 feet; thence continuing along said Tract N. 89°31'25" W. a distance of 55.80 feet to a point in the West line of a Tract described in book 516 at page 742, Deed Records; thence N. 3°30' W. along said West line a distance of 123.94 feet more or less to the point of beginning.

which property is contiguous to the present boundaries of the City of Milwaukie, Oregon, BE AND THE SAME HEREBY ARE ANNEXED TO THE CITY OF MILWAUKIE, CLACKAMAS COUNTY, OREGON.

SECTION 2. The City Recorder of the City of Milwaukie, Oregon, is hereby directed to make and submit to the Secretary of State of the State of Oregon, a copy of this Ordinance, a copy of the written consents of the owners of the territories annexed and a copy of the Ordinance of the City of Milwaukie, Oregon, being Ordinance Number 1022, declaring that no election is required in said City, and to transmit further copies of said documents to the County Assessor, the County Clerk and the County Surveyor of the County of Clackamas, Oregon.

SECTION 3. The effective date of the annexations hereinabove declared and proclaimed shall be the date upon which the documents referred to in Section 2 of this Ordinance shall have been filed with the Secretary of State, State of Oregon.
