Section 2. That the said Pacific Sanitary Service Co. shall, each month, during the life of this franchise, on a date certain appointed by this Council of Milwaukee, collect all tin cans, glass bottles, and debris of a similar nature (except garbage, swill, dead animals, and large objects like automobile bodies, wagon beds, articles of a similar size and/or nature) placed on street curbs by citizens of Milwaukee. The said Pacific Sanitary Service Co. shall receive from the City of Milwaukee for such service the sum of Eight Dollars (\$7.00) per month during the first calendar year of the franchise hereby granted and the sum of Twenty-five dollars (\$25.00) per month during each of the four years remaining. During the period of this franchise the monthly payments above referred to shall be as specified as long as the corporate limits of Milwaukee remain the same as they are now. Should the corporate limits of Milwaukee be increased the Pacific Sanitary Service Co. shall receive additional compensation to cover in the annexed territory the service described herein.

Section 3. That the said Pacific Sanitary Service Co. shall, at its expense, maintain a suitable place to dispose of all the garbage collected under this franchise and said company shall at all times keep the same in a sanitary condition.
