

ORDINANCE NUMBER 437

AN ORDINANCE providing a tax levy on all taxable property within the Town of Milwaukie, Oregon, for city purposes for the fiscal year beginning July 1, 1943 and ending June 30, 1944.

MILWAUKIE DOES ORDAIN AS FOLLOWS:

Section 1. That there be and there is hereby levied upon all taxable property situate within the corporate limits of Milwaukie, Oregon, a tax levy of Eighteen Thousand One Hundred Eighty-three Dollars and Seventy-two cents (\$18,183.72) for city purposes for the fiscal year beginning July 1, 1943 and ending June 30, 1944, and that said tax be apportioned among the several funds and departments as set forth and specified in the estimated budget of expenditures for the fiscal year beginning July 1, 1943 and ending June 30, 1944, as prepared by the Budget Committee of Milwaukie, which estimated budget in words and figures reads as follows:
