

ORDINANCE NO. 460

An ordinance granting 3 years franchise to collect garbage to the Milwaukie Sanitary Service, George Deering and Wm. G. Spady, owners.

MILWAUKIE DOES ORDAIN AS FOLLOWS:

Section 1. The Milwaukie Sanitary Service is hereby empowered and duly authorized for a period of *three* years, commencing the first day of January 1945, to operate the business of collecting or removing garbage, swill, offal, dead animals, tin cans, and all similar waste in the Town of Milwaukie, County of Clackamas, State of Oregon, under the following maximum terms and rates:

RESIDENTIAL RATES

Section 2. Per can of 25 gallons container.

One collection per week service, one can	\$1.00	per month
One " " " " two cans	1.50	" "
Two " " " " one can	2.00	" "
Two " " " " two cans	2.50	" "

Each additional container, 25¢ per can.

COMMERCIAL RATES

Section 3. Apartments, Hotels, Schools, Theaters and any business store or shop.

One collection per week service, one can	\$1.25	per month
One " " " " two cans	2.00	" "
Two " " " " one can	2.00	" "
Two " " " " two cans	3.50	" "
Three " " " " one can	3.00	" "
Three " " " " two cans	4.50	" "

Each Additional Container, 25¢ per can.

BY SPECIAL COLLECTION

Section 4. Removal of cans and broken bottles excluding garbage picked up at the time of regular trip, placed in container not to exceed 30 gallon containers, the charge will be fifty cents (50¢), and old water boilers and bed springs each fifty cents (50¢).

BULK DISPOSAL BY LOAD

Section 5. Light rubbish load not to exceed 4 cubic yards in backyard or basement \$10.00, on curb \$8.00.

REMOVAL OF DEAD ANIMALS

Section 6. Dogs and Cats \$.50.

DISPOSAL PROVISION

Section 7. That the said Milwaukie Sanitary Service shall at its expense, maintain a place satisfactory to the Town Council for the disposal of all the garbage collected under this franchise, in a sanitary condition at all times.

Section 8. That the said Milwaukie Sanitary Service shall maintain a telephone with an attendant during regular business hours.

FRANCHISE FEE

Section 9. That the Milwaukie Sanitary Service agrees to pay to the town of Milwaukie a franchise fee of \$25.00 per year, the same to be due and payable on or before the first day of March 1945. *of each year of the term of this franchise*
