

ORDINANCE NUMBER 531

AN ORDINANCE PROVIDING FOR A SPECIAL ELECTION TO BE HELD IN THE CITY OF MILWAUKIE FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF SAID CITY FOR THEIR ADOPTION OR REJECTION, A CHARTER AMENDMENT AUTHORIZING A GENERAL OBLIGATION BOND ISSUE IN AN AMOUNT NOT TO EXCEED \$200,000.00 TO BE PAID BY A GENERAL TAX OF ALL TAXABLE PROPERTY IN THE CITY OF MILWAUKIE, AND THE PROCEEDS THEREOF TO BE EXPENDED IN THE CONSTRUCTION OF A SEWAGE TREATMENT PLANT, TOGETHER WITH THE NECESSARY INTERCEPTING AND DISCHARGING SEWERS, APPROPRIATE PUMPING AND OTHER FACILITIES, INCLUDING EASEMENTS FOR INTERCEPTING AND DISCHARGING SEWERS, AND DECLARING AN EMERGENCY.

THE CITY OF MILWAUKIE DOES ORDAIN AS FOLLOWS:

Section 1. That a special election shall be held in the City of Milwaukie, Oregon on ~~Thursday~~ the 15th day of November, 1949 for the purpose of submitting to the legal voters of the City of Milwaukie for their adoption or rejection, the following proposed amendment to the Charter of the City of Milwaukie.

SEWAGE TREATMENT PLANT BONDING ACT

Section 1. A bill for an act to amend the Charter of the City of Milwaukie, Clackamas County, Oregon, by adding thereto a section which may be designated "SEWAGE TREATMENT PLANT BONDING ACT", and authorizing and empowering the City of Milwaukie to issue and sell general obligation bonds of the City of Milwaukie in an amount not to exceed \$200,000.00; which said Bonds and the interest thereon shall be paid by a general tax on all taxable property in the City of Milwaukie, and the proceeds thereof to be expended for the purpose of constructing a plant for the primary treatment of Milwaukie Sewage, together with the acquisition of appropriate easements for the intercepting and discharging sewers, and together with the appropriate pumping and other facilities for such treatment plant and intercepting sewers.

BE IT ENACTED BY THE CITY OF MILWAUKIE:-

That the City of Milwaukie be and it hereby is authorized to issue and sell General Obligation Bonds in an amount not to exceed \$200,000.00; the proceeds thereof to be expended for the purpose of constructing a plant for the primary treatment of the sewage of the City of Milwaukie on a site now owned by the City of Milwaukie; for the purpose of acquiring the necessary easements for an appropriate system of intercepting sewers and discharging sewers, for use in connection with said treatment plant, and for the purpose of acquiring the appropriate pumping and other facilities for the pumping, treatment and disposal of sewage, and to authorize and empower the said City of Milwaukie to levy and collect a general tax on all taxable property in the City of Milwaukie for the payment of the principal and interest on said bonds as they become due; and the City of Milwaukie is authorized and directed by and through its proper officers to acquire all real and personal property necessary or appropriate for such purposes, and to employ all labor that may be necessary to carry into effect the purpose for which said bonds are authorized.

Section 2. That the Ballot title for said proposed amendment shall be as follows:

SEWAGE TREATMENT PLANT BONDING ACT CHARTER AMENDMENT.

That the General Title for said proposed amendment shall be as follows:

Shall the Charter of the City of Milwaukie, Oregon be amended by adding thereto a section, wherein the said City will be authorized to issue and sell general obligation bonds in an amount not to exceed \$200,000.00 for the purpose of constructing a sewage treatment plant, also intercepting sewers with the necessary easements for the same, said bonds and interest thereon to be paid by a general tax on all taxable property in the City of Milwaukie.

Section 3. The following precincts hereby are established for said election.

Precinct 1 shall consist of voting precincts 1,2 and 3 as established by the County Clerk of Clackamas County,Oregon

Precinct 2 shall consist of voting precincts 4 and 5 as established by ~~the~~ ~~Council/Clerk/of/Clackamas/County,Oregon~~ said County Clerk

Precinct 3 shall consist of voting precincts 6 and 7 as established by said County Clerk

Section 4. The following named places are hereby designated as the polling places for said election

Precinct 1,-Polling place shall be Milwaukie City Hall 926 Main Street, Milwaukie,Oregon

Precinct 2,-polling place shall be at the Administration Building,Hillside Park in Milwaukie,Oregon.

Precinct 3,- Polling place shall be at the Administration building in Kellogg Park,Milwaukie,Oregon

Section 4 The City Recorder hereby is authorized to appoint a suitable election board for each of said voting precincts.

Section 5. It hereby is adjudged and declared that existing conditions are such that this ordinance is necessary for the immediate preservation of the public health,peace and safety;and an emergency hereby is declared to exist and that ~~it~~ this ordinance take effect and be in full force and effect immediately upon its passage and approval by the Mayor.
