

ORDINANCE NUMBER 618

AN ORDINANCE CHANGING THE NAME OF ROCKWOOD DRIVE.

THE CITY OF MILWAUKIE DOES ORDAIN AS FOLLOWS;-

Section 1. WHEREAS the the owners of all the lands comprising ARDEN PARK, CLACKAMAS COUNTY, Oregon, being outside the limits of the City of Milwaukie, but within six miles of the limits of the City of Milwaukie, have betitioned that the name of ROCKWOOD DRIVE be changed.

AND WHEREAS the Planning Commission of the City of Milwaukie has considered the matter and have recommended that the change hereinafter set forth be made, and have filed its recommendation with the Council of the City of Milwaukie.

AND WHEREAS; pursuant to such recommendation, the City Council fixed a time and place for a public hearing thereon, and ordered published in the Milwaukie Review, a newspaper published in Milwaukie, Clackamas County, Oregon; and which saida Notice was published on the 27th day of January, 1955 and the 3rd day of February, 1955, and gave notice that a public hearing would be held before the Council of the City of Milwaukie, in the Council Chambers at 8:00 P.M. on the 14th day of February, 1955, on the change of name of Rockwood Drive in Arden Park; Milwaukie, Oregon as follows;-

That part of Rockwood Drive from Lot 1, Block 7, and Lot 20, Block 6, running northerly and easterly and southerly to a northwesterly projection of the division line of Lots 22 and 23, Block 7, be re-named ARDEN STREET.

AND THAT Part of Rockwood Drive running westerly from the northwesterly northwesterly projection of the division line of Lot 22 and 23, of said Block 7 to the westerly line of the Plat, be renamed ROCKWOOD STREET.

AND WHEREAS said public hearing was held as specified in said notice, and no person appeared to object to such change of name.

SECTION 2. It is therefore declared and the Name of Rockwood Drive hereby is changed as follows;-

That part of Rockwood Drive from Lot 1, Block 7 and Lot 20, Block 6 running northerly and easterly and southerly to a northwesterly projection of the division line of Lots 22 and 23, Block 7, all in ARDEN PARK, be renamed ARDEN STREET.

And that part of Rockwood Drive running westerly from the northwesterly projection of the division line of Lots 22 and 23 of said Block 7 to the westerly line of the said Plat, be re-named ROCKWOOD STREET.

Read the first time this 14th day of March, 1955.

Read the second time and passed by the Council the 14th day of March, 1955.
