

ORDINANCE NUMBER 629

AN ORDINANCE ANNEXING CERTAIN TERRITORY CONTIGUOUS TO THE PRESENT BOUNDARIES OF THE CITY OF MILWAUKIE, CLACKAMAS COUNTY, OREGON, AND FIXING THE EFFECTIVE DATE OF SUCH ANNEXATION.

THE CITY OF MILWAUKIE DOES ORDAIN AS FOLLOWS:

Section 1. The Council of the City of Milwaukie, Oregon, having heretofore, by Ordinance No. 626 duly passed and approved on the 13th day of December, 1955, dispensed with submitting the question of the annexation of the territory hereinafter described to the registered voters of the City of Milwaukie, Oregon, and having heretofore, by said Ordinance, fixed the 9th day of January, 1956, as the day for hearing at which time the registered voters of said city might appear and be heard on the question of said annexation before it, and all required notices relating to such hearing having heretofore been published and posted as required by the provisions of Section 222.120, Oregon Revised Statutes, and the public hearing having been had by the City Council of the City of Milwaukie pursuant to such notices, and no registered voters of the City of Milwaukie, Oregon, appearing at said hearing who protested said annexation, and Morris C. Martin and Ada R. Martin, his wife, and M. Clifford Martin, Jr. and Margaret E. Martin, his wife, the sole owners of record of the territory to be hereby annexed having heretofore, and on the 6th day of January, 1956, given and filed their written consent to said annexation to and with the City Council of the City of Milwaukie, Oregon, IT IS HEREBY DECLARED AND PROCLAIMED that the following described territory, situated in the County of Clackamas and State of Oregon, to-wit:

Beginning at a point that bears South 89° 17' East 630.00 feet to the northeast corner of Lot 9, Block 1, KEIL HEIGHTS, a Townplat recorded in Volume 24 on Page 14, Record of Townplats for Clackamas County, Oregon, and South 0° 36' 30" West 555.95 feet along the east boundary of said KEIL HEIGHTS, from the Northwest corner of the John D. Garrett D.L.C. No. 38; thence South 89° 17' East 315.80 feet to the southwest corner of Lot 21, Block 5, MARTIN HEIGHTS, as recorded in Volume 27 on Page 18, said RECORD OF TOWNPLATS; thence North 0° 35' 04" East along a west boundary of said MARTIN HEIGHTS, 309.57 feet; thence North 89° 14' 36" West, 315.42 feet to the east boundary of said KEIL HEIGHTS; thence South 0° 36' 30" West 309.97 feet to the place of beginning.

being territory contiguous to the present boundaries of the City of Milwaukie, Oregon, be and the same is hereby annexed to the City of Milwaukie, Oregon.

Section 2. The City Recorder of the City of Milwaukie, Oregon, is hereby directed to make and submit to the Secretary of State of the State of Oregon a copy of this Ordinance, a copy of the written consent of the owners of all of the territory annexed, and a copy of the Ordinance of the City of Milwaukie, Oregon, being Ordinance No. 626, declaring that no election is required in said City, and to transmit further copies of said documents to the County Assessor, the County Clerk, and the County Surveyor of the County of Clackamas, State of Oregon.

Section 3. The effective date of the annexation hereinabove declared and proclaimed shall be the date upon which the documents referred to in Section 2 of this ordinance shall have been filed with the Secretary of State of the State of Oregon.

Read the first time this 9th day of January, 1956.

Read the second time and passed this 16th day of January, 1956.
