

ORDINANCE NUMBER 635

AN ORDINANCE AMENDING ORDINANCE NO. 598 BY DELETING CERTAIN SECTION NUMBERS OF OREGON REVISED STATUTES THEREFROM, AND BY SUBSTITUTING OTHERS THEREFOR, AND DECLARING AN EMERGENCY.

THE CITY OF MILWAUKIE DOES ORDAIN AS FOLLOWS:

Section 1. That Ordinance No. 598 of the City of Milwaukie, Oregon be and the same hereby is amended by deleting therefrom all reference to Sections 486.990, 486.300, 486.105 and 486.110 of Oregon Revised Statutes.

Section 2. That Ordinance No. 598 be and the same is hereby further amended by adding to the list of sections of the Oregon Revised Statutes therein set forth the following sections of Oregon Revised Statutes numbered as follows: Section 486.991, Section 486.301, Section 486.106 and Section 486.111.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Milwaukie, Oregon, and the inhabitants thereof, in this, that it is urgently and immediately necessary for the proper and effective enforcement of the traffic laws of said city and for the protection of all persons using the streets and highways within said city; therefore, an emergency is hereby declared to exist and this ordinance shall take effect and be in full force and effect from and after its passage and the signing by the Mayor.
