

ORDINANCE NUMBER 636

AN ORDINANCE ANNEXING CERTAIN TERRITORY CONTIGUOUS TO THE PRESENT BOUNDARIES OF THE CITY OF MILWAUKIE, CLACKAMAS COUNTY, OREGON, AND FIXING THE EFFECTIVE DATE OF SUCH ANNEXATION.

THE CITY OF MILWAUKIE DOES ORDAIN AS FOLLOWS:

Section 1. The City of Milwaukie, Oregon, having heretofore, by Ordinance No.632, duly passed by the Council of the City of Milwaukie on the 23rd day of January,1956 and approved and signed by the Mayor of the said City, on the 23rd day of January,1956, dispensed with submitting the question of the annexation of the territory hereinafter described, to the registered voters of the City of Milwaukie, Oregon, and having heretofore, by said Ordinance, fixed the 13th day of February,1956, as the day for hearing at which the registered voters of said City might appear and be heard on the question of said annexation before it, and all required notices relating to such hearing having heretofore been published and posted as required by the provisions of Section 222.120, Oregon Revised Statutes, and the public hearing having been had by the City Council of the City of Milwaukie pursuant to such notices, and no registered voter of the City of Milwaukie, Oregon, appearing at said hearing who protested said annexation, and School District No. 1, Clackamas County, Oregon, the sole owner of record of the territory to be hereby annexed, having heretofore and on the 19th day of January, 1956, given and filed its written consent to said annexation to and with the City Council of the City of Milwaukie, Oregon, IT IS HEREBY DECLARED AND PROCLAIMED that the following described territory, situated in the County of Clackamas and State of Oregon, to-wit:-

*School* Beginning at the northwest corner of the John D. Garrett D.L.C. No. 38 Section 31, T.1 S., R. 2 E. of the W.M. thence tracing the North line of said John D. Garrett D.L.C. South 89° 17' East 1260.23 feet to an iron pipe; thence South 0° 30' West 1068.54 feet to an iron pipe which is the true place of beginning; thence South 0° 30' West 1089.21 feet to an iron pipe in the Northerly boundary of the S.S. Fields Rd. No. 1438; thence tracing the Northerly boundary of said Fields Road, South 55° 17' East 428.82 feet to an iron pipe which is in the East line of that certain tract of land conveyed to Antonette Walsh by deed recorded in Book 161, page 299, Deed Records of Clackamas County, Oregon; thence North 0° 17' 45" East along the Easterly boundary of the said Antonette Walsh tract 1328.96 feet to an iron pipe, thence North 89° 17' West 349.32 feet more or less to the place of beginning, Except, therefrom the West 40 feet thereof determined by a line drawn parallel to and 40 feet Easterly from the West line of the tract herein described, in the County of Clackamas and State of Oregon.

which property is contiguous to the present boundaries of the City of Milwaukie, Oregon, BE AND THE SAME IS HEREBY ANNEXED TO THE CITY OF MILWAUKIE, OREGON.

Section 2. The City Recorder of the City of Milwaukie, Oregon is hereby directed to make and submit to the Secretary of State of the State of Oregon a copy of this Ordinance, a copy of the written consent of the owners of all of the territory annexed, and a copy of the Ordinance of the City of Milwaukie, Oregon, being Ordinance No.632, declaring that no election is required in said City, and to transmit further copies of said documents to the County Assessor, the County Clerk, and the County Surveyor of the County of Clackamas, State of Oregon.

Section 3. The effective date of the annexation hereinabove declared and proclaimed shall be the date upon which the documents referred to in Section 2 of this Ordinance shall have been filed with the Secretary of State of the State of Oregon.
