

ORDINANCE NUMBER 665

An Ordinance Vacating a portion of Magnolia Avenue, also known as Llewellyn Street, in the plat of Minthorn Addition to the City of Portland, Oregon

The City of Milwaukie Does Ordain as Follows:

Section 1. Pursuant to Resolution Number 3-1957, duly adopted by the Council of the City of Milwaukie, Oregon on the eleventh day of February, 1957, and a public hearing held, pursuant to Section 271.130, Oregon Revised Statutes, on the Eleventh day of March, 1957, and upon due notice given as required by section 271.110 Oregon Revised Statutes, and there having been no objections thereto, the City of Milwaukie does hereby vacate that portion of Magnolia Avenue, also known as Llewellyn Street in the Plat of Minthorn Addition to the City of Portland, Oregon, recorded in Book 3, Pages 5 to 11 inc. Record of Townplats, and more particularly described as follows:

Beginning at the southwest corner of Block 12, Minthorn Addition to the City of Portland, Oregon, a Townplat recorded in Book 3 on Pages 5 to 11 inclusive, record of townplats; running thence Easterly along the south line of said Block 12, to the southeast corner thereof; thence southerly to the northeast corner of Block 17, said Minthorn Addition; thence Westerly along the north line of said block 17, to the northwest corner thereof; thence Northerly to the place of beginning.
