

WHEREAS, the City of Milwaukie, by appropriate statutory procedure, has heretofore annexed the following described tracts of real property bounded as follows:

PARCEL I - The West 60.00 feet from the following described property: The South 16.21 feet of Lot 9 and all of Lot 10, EXCEPT the South 95.00 feet thereof, in GIBSON'S SUBDIVISION OF TRACTS 10, 11, 12, and 13 and the West 480.00 feet of Tracts 1 and 2 of the Logus Tracts, County of Clackamas and State of Oregon.

PARCEL II - The West 60.00 feet of the following described property: The North 55 feet of the South 71.21 feet of Lot 9, GIBSON'S SUBDIVISION OF TRACTS NUMBERED 10, 11, 12 and 13, and the West 480 feet of Tracts 1 and 2, of the LOGUS TRACTS, in the County of Clackamas and State of Oregon, as recorded in Volume 7, page 47, Plat Records.

PARCEL III - The North 560 feet of the West half of the West half of Tract 7, Logus Tracts, except a 40 foot strip of the land deeded to the County and except that portion of said property within the plat of Milcrest, in the County of Clackamas and State of Oregon.


AND WHEREAS, the above described real properties lie within the boundaries of the MILWAUKIE RURAL FIRE PROTECTION DISTRICT NO. 56, a fire protection district in the County of Clackamas and State of Oregon, duly organized and existing under and by virtue of the laws of the State of Oregon.

NOW THEREFORE BE IT HEREBY RESOLVED BY THE CITY COUNCIL of the City of Milwaukie, Oregon, that it does hereby elect to cause the withdrawal from the said Milwaukie Rural Fire Protection District, all that part of said Fire District hereinabove described and heretofore incorporated in and annexed to the City of Milwaukie, Oregon.

BE IT FURTHER RESOLVED, by the City Council of the City of Milwaukie, Oregon, that by virtue of the foregoing and by virtue of the provisions of Sections 222.520 and 222.524, Oregon Revised Statutes, May 12, 1969, is hereby fixed as the date, the hour of 8:30 p.m. Pacific Daylight Time, is hereby fixed as the time, and the Council Chambers of the City Hall, 926 Main Street, Milwaukie, Oregon, is hereby fixed as the place, for a public hearing to be held by the Council of the City of Milwaukie, Oregon, to hear objections to the withdrawal of the above described boundaries from the MILWAUKIE RURAL FIRE PROTECTION DISTRICT NO. 56, and to determine whether such withdrawal is for the best interests of the City of Milwaukie, Oregon, and

BE IT FURTHER RESOLVED, that the City Recorder of the City of Milwaukie, Oregon, be and he hereby is, ordered and directed to cause a notice of the date, time, place, and purpose of said hearing to be published once each week for two successive weeks prior to the date of such hearing, in the MILWAUKIE REVIEW, a newspaper of general circulation in said City, and that he further cause notices of the date, time, place and purpose of said hearing to be posted in four public places within the City of Milwaukie, Oregon, for a like period of time.
