Whereas, the above described portion of said County Road has never been improved by the County, and the Town of Milwaukie desires to acquire jurisdiction over the same:

NOW THEREFORE, be it resolved by the Council of the Town of Milwaukie, that it is deemed necessary and expedient and for the best interests of said Town of Milwaukie to acquire jurisdiction over the above described portion of said County Road to the same extent as the said Town of Milwaukie has over other public streets and alleys therein:

AND BE IT FURTHER RESOLVED that the Town of Milwaukie request the said County of Clackamas and the County Court thereof, to surrender jurisdiction over the above described portion of said County Road.

RESOLUTION NUMBER 7-1924

WHEREAS, on the 17th day of May, 1924, at a meeting of the Council of the Town of Milwaukie, regularly called and held, a resolution was unanimously adopted, reciting that the said Council deemed it necessary and expedient and for the best interests of said Town of Milwaukie to acquire jurisdiction over a certain portion of a County Road lying within the corporate limits of said Town, and described as follows:

Beginning at an iron pipe on the true west line of Front Street in said Town of Milwaukie, County of Clackamas and State of Oregon, according to the official plat of the Town of Milwaukie on file in the office of the Recorder of Conveyances of Clackamas County, Oregon, 71.50 feet north 10 degrees west from the intersection of the center line of Jefferson Street and the true west line of said Front Street; thence south 89 degrees west 332.55 feet to an iron spike on the east meander line of the Willamette River; thence south 10 degrees east 60.75 feet following the meander upstream of said Willamette River; thence north 89 degrees east 332.55 feet to a point on said true west line of Front Street; thence north 10 degrees west 60.75 feet along the said true west line of Front Street to the place of beginning.

AND WHEREAS, the said Town by said resolution requested the County of Clackamas, State of Oregon, and the County Court thereof to surrender to said Town jurisdiction over the above described portion of said County Road;

AND WHEREAS, pursuant to said resolution, a petition was filed by said Town, addressed to the said County Court, embodying the said resolution, and the foregoing request;

AND WHEREAS, thereafter such proceedings were had in said County Court, that on the 6th day of August, 1924, said County Court made and entered an order in compliance with the prayer of said petition, offering to surrender to said Town jurisdiction over said above described portion of said County Road; provided that such offer should be accepted by said Town by appropriate resolution or ordinance within thirty days from date of said order:

NOW THEREFORE BE IT RESOLVED by the Council of the Town of Milwaukie, that the offer of the County of Clackamas to surrender jurisdiction over said portion of said County Road as set forth in said order be and the same is hereby accepted, and that said Town of Milwaukie henceforth assumes jurisdiction over said portion of said County Road, for its improvement, construction and repair, and for the levying and collection of assessments therefor, and for the control thereof and over the same to the same extent and in like manner as it has jurisdiction of and controls the public streets and alleys of said Town by

virtue of the provisions of its charter and the laws of the State of Oregon.

AND BE IT FURTHER RESOLVED, that the acceptance of said offer be communicated to said County of Clackamas and to the County Court thereof in compliance with the provisions of said order by filing in the office of the County Clerk of said County a certified copy of this resolution.

RESOLUTION NUMBER 1-1925

BE IT RESOLVED by the Council of the Town of Milwaukie that the following entitled proposed amendments to the Charter of the Town of Milwaukie, Oregon, be submitted to a vote of the legal voters of the Town of Milwaukie at a special city election to be held therein on Monday the 18th day of May, 1925, for their adoption or rejection: "A Bill for an Act to amend the Charter of the Town of Milwaukie, in the County of Clackamas and State of Oregon, by adding thereto the following sections, which shall be designated and may be cited as the Street Paving Amendment, authorizing and empowering the Town of Milwaukie to pave with hard surface pavement to a width of sixteen (16) feet the following streets in said Town: Washington Street from 27th Street to Elmer Street; Elmer Street from Washington Street to Oak Street; Oak Street from Elmer Street to East Monroe Street; East Monroe Street from Oak Street to 42nd Street; Harrison Street from the end of the present pavement to 42nd Street, and 32nd Street from Harrison Street northerly to the city limits, and for that purpose to issue and dispose of general obligation bonds of the Town of Milwaukie in the amount not exceeding Thirty-five Thousand (\$35,000.00) Dollars, and to levy and collect a special annual tax not exceeding five and one-half ($5\frac{1}{2}$) mills on the dollar on all the taxable property within the Town of Milwaukie, Oregon, until said bonds are paid; also A Bill for an Act entitled, "A Bill for an Act to amend the Charter of the Town of Milwaukie, in the County of Clackamas and State of Oregon, by adding thereto the following sections, which shall be designated and may be cited as the "Sewer Construction Amendment," to authorize and empower the Council of the Town of Milwaukie, Oregon, to construct and lay sewers and drains, with all man-holes, lamp-holes, catch basins and branches, and to repair and relay the same and to levy and collect an assessment upon all lots and parcels of land specially benefited by such sewers or drains, to defray the whole or any portion of the cost and expense thereof, and to determine what lands are specially benefited by such sewer or drain, and the amount to which each lot or parcel of land is benefited; to provided the manner of the payment of the assessment levied to pay the cost and expense of said sewer or drain, and authorizing the issuance of improvement bonds, and to repeal all provisions of the Charter and ordinances of the Town of Milwaukie in conflict herewith."

RESOLUTION NUMBER 2-1925

RESOLUTION AND NOTICE OF THE IMPROVEMENT OF 32ND STREET FROM THE NORTH PROPERTY LINE OF HARRISON STREET NORTHERLY TO THE CITY LIMITS.

Whereas, pursuant to an order of the Council of the Town of Milwaukie, Oregon, heretofore made, the City Engineer has filed his report and filed in the office of the Recorder of said Town plans and specifications for an appropriate improvement of 32nd Street from the north property line of Harrison Street northerly to the city limits, according to the petition heretofore filed, together with an estimate of the work to be done and the probable cost thereof, and whereas,
