Call for Sculptors

2016-2017

City Hall Sculpture Garden

Milwaukie, Oregon

Deadline: Aug. 17, 2016

The Milwaukie Arts Committee (artMOB) is pleased to invite sculptors to submit proposals for Milwaukie's outdoor sculpture garden and Dogwood Park. Sculptures will be on display at the south lawn of City Hall along Jackson Street and at Dogwood Park located on Main Street near the new MAX Station and pedestrian bridge over Kellogg Creek. The four pieces selected will be displayed for two years from September 2016 to August 2018. At the time of installation the sculptures must be available for purchase. The City Hall Sculpture Garden has six pedestals for displaying a rotating sculpture collection—half of which are new every year. Dogwood Park has two pedestals, one of which is available for displaying a rotating sculpture for a two year rotation.

The Milwaukie Arts Committee will provide each selected artist with an **honorarium of \$900**. Artists will be asked to install the pieces themselves. A liability waiver and contract must be signed with the City prior to installation.

Exhibit

- For this installation the Milwaukie Arts Committee seeks pieces which represent **a theme of the artist's choice**.
- The sculpture must be of suitable scale for **outdoor public art**, free standing and of high artistic quality.
- **We are seeking four pieces that fit on our small pedestals. Three in the sculpture garden and one in Dogwood Park.**
- Pieces must fit on our small pedestals and mounting systems. For this call we have three small pedestals which are 24" by 24" (two feet by two feet) and one pedestal that is 36" x 36" (three feet by three feet). Pedestals have ½ inch holes at each corner 21 inches apart (center to center) and a second set of holes in a square 10 inches apart. See further details and photos below.
- The artwork will require minimum maintenance and be able to withstand the effects of weather, be as resistant as possible to vandalism, able to withstand possible pedestrian contact and not impede either walking or driving traffic and be safe. **ADA guidelines** are considered in placement of each sculpture.
- Sculpture will be **"on loan"** to the City during the exhibition period and must be **available for sale** to the public. If a sculpture sells, the artist is responsible for replacing the piece with another of the same quality and scale at the time of removal of the sold artwork. The replacement sculpture must be approved by the Selection Committee before the sculptures are moved and will be on exhibit for the remainder of the two-year loan period. There will be a 20% Gallery Fee paid to the Milwaukie Arts Committee for any sculpture sold while on exhibit in the **City Hall Sculpture Garden or Dogwood Park**.
- **Pedestals** are provided in the City Hall Sculpture Garden and Dogwood Park. **Anchoring method in the Sculpture Garden are bolts underneath the steel plate hidden by landscaping. There are no anchoring mechanisms for the concrete pad in Dogwood Park. The artist shall propose an anchoring method with submission of Dogwood Park proposal and be responsible for installation of said mechanism provided his or her proposal is selected for installation.** Sculpture Garden submissions must fit respective pedestal and mounting system in Sculpture Garden. See further details and photos below.
- It is the **artist's responsibility to deliver and install the sculpture** at the specified site in the September of 2016, and then **remove the work** from the site at the end of the exhibition period.
- The Milwaukie Arts Committee **reserves the right to reject work** that, when completed differs from the original proposal, or does not meet standards of durability and quality.
- Each sculptor will enter into a **contract with the city** of Milwaukie for sculpture that will be on loan to the city for a one year exhibition period and must be for sale.

Selection Process

The Milwaukie Arts Committee will select artists that have the ability to loan the City of Milwaukie a work of art and can meet the following parameters:

Schedule:

- **August 17, 2016, 5:00 PM** - Artist proposals must reach City Hall.
- **August 26, 2016** - Artists will be notified of the Selection Committee's decision regarding proposal.

- **September 30, 2016** - All sculpture must be installed by the 30th. You may install any time in September if you prefer.

Portfolio Proposal Information Needed:

- **Resume:** A current resume that includes artist name, day/evening/cell phone, email, internet and mailing addresses and website, if applicable.
- Minimum **300 dpi**, maximum **1MG .jpg** images of recent work.
- **Details about proposed sculpture:** Please include **three photos** of the work from different angles with at least one image showing scale (e.g. with an adult standing next to the piece). Height, width, depth, weight, medium, color, base size should be included. A maquette depicting the finished work is most welcome.
- **Proposals for work not yet fabricated:** If you propose work that is not yet fabricated, please submit a detailed illustration for each entry. Indicate size (height, width and depth), medium, anticipated weight and color.
- **Artists Statement:** A statement (1 page maximum) that describes your work (inspiration, personal statement) particular to each entry and suitable for publication.
- Note: **MUST** include all the preceding items for your submission to be considered.

Deadline for Proposal Information

All materials listed above must be received by **Aug 17, 2016 at 5:00PM**. If materials are received later than this the Selection Committee reserves the right to hold those materials until the following year.

Pedestal Information:

1. Sculpture Garden pedestals are 24" by 24" with ½ inch holes at each corner 21 inches apart (center to center) and a second set of holes in a square 10 inches apart. The steel plate 'floats' above the concrete pedestal attached via rebar. Sculptors may mount the piece to the steel plate with ½ inch bolts. See further details and photos below.
2. Dogwood Park pedestals are 36" x 36" concrete pads suitable for drilling and attaching anchoring mechanism of choice by artist.
