Subject: Fireworks Ban Discussion

#### **ACTION REQUESTED**

Council is asked to give direction related to the attached proposed ordinance, which would ban the sale, possession, and use of fireworks in Milwaukie.

#### HISTORY OF PRIOR ACTIONS AND DISCUSSIONS

May 2, 2017: Milwaukie Municipal Code (MMC) Chapter 9.18 Fireworks was adopted, which made the sale, possession, and use of fireworks that are not available to the general public, a violation of the code.

<u>July 1, 2021</u>: Council adopted Resolution 39-2021, which ratified the city manager's declaration of emergency and banned the use of fireworks from June 29, 2021, through July 9, 2021.

<u>November 15, 2022</u>: Council had a discussion and received a presentation from Clackamas Fire District #1 (CFD1). Council provided direction to city staff to prepare a proposed ordinance to ban fireworks.

#### **ANALYSIS**

#### **Oregon Revised Statutes**

Oregon Revised Statutes 480.111-480.165 regulates fireworks. ORS 480.111 defines "fireworks" as consumer fireworks, display fireworks, exempt fireworks, pyrotechnic articles, and special effects.

Consumer fireworks include a cone fountain, a cylindrical fountain, a flitter sparkler, a ground spinner, an illuminating torch or a wheel, or a combination of two or more of those items; and any other items, other than exempt fireworks, containing 500 grams or less of pyrotechnic composition that the State Fire Marshal recognizes by rule to be suitable for retail sale. Consumer fireworks may be sold to the public from June 23 - July 6 each year from retailers with a permit issued by the State Fire Marshall. Consumer fireworks are sold at local retailers and at temporary fireworks stands in Milwaukie.

Display fireworks are designed for travel into the air or to project effects from a fixed position. Display fireworks are not sold to the general public in Oregon.

Exempt fireworks are what might be described as less incendiary fireworks and other items not usually referred to as fireworks. These include snakes and other smoke producing items with less than 100 grains or less of combustible substances, paper caps for toy guns, model rockets, novelties and trick noise makers, and flare guns. There are no restrictions on the sale of these items by ORS 480.111 - 480.165.

Pyrotechnic articles are designed for professional use, are similar to consumer fireworks in chemical composition and construction, contain 500 grams or less of pyrotechnic composition, are not labeled as consumer fireworks.

Special effects are articles containing pyrotechnic composition that, subject to authorization from the appropriate jurisdiction, are manufactured, assembled, designed or discharged in connection with television, theater or motion picture productions, concerts or conference centers, or used for commercial, industrial, educational, recreational or entertainment purposes.

#### Code

The MMC currently authorizes police and code enforcement staff to issue citations for the sale, possession, and use of fireworks that are not sold to the general public in Oregon with a maximum fine of \$1,000. The code also prohibits the use and possession of any fireworks in city parks, which is subject to citation and a maximum fine of \$500.

#### **Proposed Ordinance**

The proposed ordinance would prohibit the sale, possession, and use of all fireworks, except exempt fireworks as defined by ORS 480.111. This would prohibit the sale, possession and use of firecrackers, bottle rockets, Roman Candles, sparklers, fountains, cones, wheels, and any consumer fireworks, display fireworks, pyrotechnic articles, and special effects. This proposed ordinance is similar to the City of Portland's treatment of fireworks. The proposed ordinance will prohibit professional shows and does not provide a permitting process.

#### **Enforcement Methods**

Since Chapter 9.18 Fireworks was adopted in 2017, 14 citations have been issued by police and code enforcement staff.

During the 2021 fireworks season (late June - early July), the region experienced extreme drought conditions and Council passed Resolution 39-2021, which ratified the city manager's declaration of emergency and associated fireworks ban from June 29 through July 9. Retailers with valid permits to sell fireworks were already selling fireworks so staff provided leaflets to be distributed by the retailers to their customers.

During the 2021 ban, code enforcement staff worked overtime on July 3 and 4 for the first-time as part of any fireworks enforcement. If Milwaukie residents were found using any fireworks, police and code enforcement provided information to residents and issued a warning about the temporary ban. During these enforcement efforts, residents expressed frustration that they had purchased fireworks from permitted retailers and claimed to have not been informed of the ban. Messaging from staff was that the ban would only last until July 9. On July 4, one citation was issued by code enforcement to a person using consumer fireworks that had previously been warned by a police officer. One citation was issued to a resident for the use of display fireworks. The fine issued for each violation was \$1,000.

During the 2022 fireworks season, code enforcement again worked overtime, and no additional police officers were used. Code enforcement staff worked July 3 and 4. On July 3, two citations were issued for the use of display fireworks and five display fireworks were confiscated. On July 4, code enforcement staff responded to complaints as did police officers. Code enforcement did not issue any citations that night.

Due to budgetary constraints, staffing challenges, and general police call load on holidays, there will be no additional capacity to provide resources dedicated to the enforcement of this proposed ordinance.

#### Other Jurisdictions

There are a few cities in Oregon that have adopted a local ordinance specific to fireworks. Bend, Eugene, Portland, and Cannon Beach have banned the sale, possession, and use of fireworks. Happy Valley and Lake Oswego have similar provisions that prohibit display fireworks and consumer fireworks tied to fire risk levels. Grants Pass has banned the use of consumer fireworks in certain areas, during periods of heightened fire danger, and anytime outside of 6:00 p.m. to 11:00 p.m. on July 4.

Enforcement methods vary between jurisdictions as well. Bend is requesting that complaints regarding consumer fireworks be sent via email. Fireworks complaints that involve an immediate safety concern should be called into dispatch.

Portland does not actively patrol for violations, but any fires generated by fireworks that cause damage, regardless of the type of fireworks used, are charged with arson.

Eugene has a webpage dedicated to their fireworks ban, which was adopted in October 2022. The webpage provides contact information for their non-emergency dispatch to report display fireworks. The webpage does not indicate what someone should do if they see someone using consumer fireworks. Eugene is facing a budget crisis and does not foresee any extra resources being used for enforcement of the newly passed ordinance.

Cannon Beach held a large public outreach campaign the first year they implemented their ban. The entire Cannon Beach police department was deployed on July 4 the first year. The city used Community Emergency Response Team volunteers to assist with reporting violations occurring on the beach and regular patrol last year.

The table below provides an analysis of other jurisdictions and Milwaukie's current code. These cities have adopted an ordinance in some form so they may issue citations to their local municipal court. Something to be aware of is that it is standard language in most jurisdictions in Oregon to have a prohibition for fireworks of any type in their parks.

#### **BUDGET IMPACT**

Minimal budget impacts are anticipated. There are no anticipated budgetary impacts for additional staffing or additional overtime from prior years of enforcement. Some outreach materials have not been budgeted but should not impact overall budget.

#### **WORKLOAD IMPACT**

The code compliance department anticipates some workload impacts related to this ordinance. Outreach to retailers of fireworks, community groups that have permitted sales with the city in the past, and to the public through the Pilot and social media.

The Lake Oswego Communications Center (LOCOM) handles all emergency and non-emergency calls for service in Milwaukie. LOCOM can expect some increased call load if the proposed ordinance is adopted. They will not adjust staffing specifically related to anticipated calls regarding violation of this ordinance. LOCOM does adjust staffing on holidays to account for general call-load and anticipated safety factors.

Milwaukie enforcement workload will not change.

#### **CLIMATE IMPACT**

The proposed ordinance is not intended to reduce emissions but is partially in response to the increased drought and wildfire risk due to climate change. Many times, when a fire is created by fireworks, vegetation and trees are lost. Tree loss and wildfire smoke increase community emissions and worsen air quality in the region.

#### COORDINATION, CONCURRENCE, OR DISSENT

The code enforcement department, police department administration, and city attorney have reviewed the ordinance and concur that this ordinance is written in a manner that fireworks will not be allowed in the city for sale, possession, or use.

#### STAFF RECOMMENDATION

Staff recommends that if Council chooses to ban the sale, possession, and use of fireworks, Council should invite staff back to the February 21 regular session to present the proposed ordinance for adoption.

#### **ALTERNATIVES**

Council may give direction to staff to not move forward with an ordinance at this time or to modify the ordinance prohibitions in some fashion.

#### **COUNCIL ORDINANCE No.**

#### **DRAFT ORDINANCE**

AN ORDINANCE OF THE CITY OF MILWAUKIE, OREGON, AMENDING CHAPTER 9.18 FIREWORKS TO PROHIBIT THE SALE, POSSESSION AND USE OF CONSUMER FIREWORKS.

WHEREAS the citizens of Milwaukie value a safe and livable community; and

WHEREAS the use of fireworks has a negative impact on veterans and other citizens, as well as pets in our homes and wildlife in our yards, parks, and natural areas; and

**WHEREAS** fireworks also pose a public safety threat due to fire hazard to both homes and other structures as well as parks and natural areas, especially in dry summer months.; and

#### Now, Therefore, the City of Milwaukie does ordain as follows:

Section 1. <u>Amendments</u>. The Milwaukie Municipal Code (MMC) is amended:

#### 9.18.010. Prohibited Acts.

Unless otherwise permitted by the terms of ORS 480.120(1)(a-g), it is unlawful for any person to sell, offer for sale, expose for sale, possess, use, explode or have exploded any fireworks.

#### 9.18.020. Definitions

As used in this chapter:

"Fireworks" means the same as defined in ORS 480.111, but does not include "Exempt fireworks" as defined in ORS 480.111.

"Person" means a natural person, firm, partnership, association, or corporation.

#### 9.18.030. Violation-Removal

The City may confiscate, destroy, remove or have removed at the owner's expense all stocks of fireworks in violation of this chapter, when necessary to preserve public safety.

#### 9.18.040. Violation- Penalty

A. Any person who violates this chapter is subject to a fine not to exceed \$1,000.

B. Each day a violation of a provision of this chapter occurs will constitutes a separate offense.

Section 2. <u>Effective Date</u>. The amendments will become effective 30 days from the date of adoption.

Thank you for reading my email and getting back to me.

Our church is not within Milwaukie city limits and the tent that we, ourselves, run is located at OG Fred Meyer - in unincorporated Clack County. So you're right when you say that this law/ban would not necessarily affect us by shutting us down but a few things I would ask you to take into consideration:

- 1.) I do know others that run stands within Milwaukie city limits that are in a similar situation as us. Without these funds we can not do what we need to do in order to help families and kids. This one fundraiser is an absolute game changer for helping people who we woundn't be able to help otherwise. We've tried all the other options car washes, selling jerky sticks, candy bars, collecting soda bottles, garage sales, etc... and none of them come even remotely close to making the kinds of funds that we need to help the needy folks that we have.
- 2.) Though our church is not within Milwuakie proper the decisions you make do impact us greatly. Though Rex Putnam isn't a "Milwaukie" school it is still a Milwaukie school. The people that attend our church and live in 97267 still say they live in "Milwaukie." We are proud to call Milwaukie our home even though some of our homes may lie a mile or so outside of official borders. On the flip side of that, some of our folks do live within 97222 so this is an issue with direct consequence for them.
- 3.) If this passes, we still might be able to run our stand but it will increase hostility and division. When Portland decided they were going to do this (2 years ago I believe) we had all kinds of people come to our stand yelling at us, calling us names, demonizing us. Many were ignorant and thought the ban was for everyone and everywhere BUT others simply felt validated to come and harass and intimidate. Alot of people who live in our area don't differentiate between Portland and the "metro area" and even less people understand where unincorporated Clackamas County and Milwaukie begin and end. I guess I'd just ask the city leaders in a already very divided world, is this really an issue that

is worth drawing another one of those lines? I'm of the opinion that it is not and I'm sure there are many who disagree with me but I'd ask you to consider this as you're trying to determine the best way to move forward.

4.) Is the real issue fireworks OR something else? I'm not even sure what issue it is you're trying to solve by talking about banning fireworks? So rather than banning them - and ruining that for the massive majority of responsible, law-abiding people who use them - why not just crack down hard when they are used irresponsibly? I would encourage you not to penalize the right kind of people for the deeds of what the wrong kind of people do.

This issue does impact alot of people and like so many issues today - I'm sure there is much passion and fire on both sides. So thank you again for taking the time necessary to work though all sides of the conversation.
