4. EXECUTIVE DIRECTOR'S BUDGET MESSAGE

Ms. Aman presented the budget message to the committee. There is a correction to the letter, debt issuance should read \$2 million; the budget is correct. She explained the goals of the commission: form a citizen advisory committee, develop a 5 year action plan and secure debt for capital projects.



5. DELIVERY OF BN 2021-2022 PROPOSED BUDGET

Ms. Aman presented the budget.

6. BUDGET REVIEW AND DISCUSSIONS

Mayor Gamba asked if the tax projections have been reviewed since the change in the economy.

Ms. Dennis responded this budget takes that into account; it is a conservative approach.

Ms. Batey asked how projections in the original urban renewal plan compare to the actual tax increment financing.

Ms. Aman responded the actual numbers are tracking a little above what was projected.

Ms. Batey asked where in the fund summary does it reflect the \$495,000 and anticipated \$609,000 that is stated in the budget message.

Ms. Dennis responded \$495,000 is the ending fund balance for the biennium.

Ms. Batey asked where the \$609,000 is reflected in the budget.

Staff will check the amount and update the letter.

Ms. Hyzy asked for clarification that the citizen committee will determine how the money is spent and asked how the money might be spent.

Ms. Aman responded the 5-year action plan will determine how the money will be spent but at this time she does not know the specific projects. Possibly programs supporting store fronts, tenant improvements, and small business. It is difficult to say what the committee would recommend.

8. VOTE TO APPROVE BUDGET TO COUNCIL BY MRC BUDGET COMMITTEE

It was moved by Ms. Parks and seconded by Ms. Hyzy to approve the property taxes for the 2021-2022 fiscal year for the maximum amount of revenue that may be raised by dividing the taxes under section 1c, Article CI of the Oregon Constitution and Oregon Revised Statutes Chapter 457.
