II. REPORTS

A. Clackamas County Fire Report

- About 13k calls year to date
- In comparison to last three years fire calls are down from last year, but EMS are about the same
- The fire District is planning several open houses for Fire Prevention Month in October
- 10 Firefighters recently graduated from their academy and are now out the crews serving the community
- As of the end of July, the Fire District has not been deployed on any wildfire conflagration in the state.
- Fire restrictions are in place include agriculture until 8/1/22—BBQ is still ok
- Willamette is 75 degrees

B. Milwaukie Police Report—Robbie Graves

- 19th and Sparrow has been checked out by swing shift workers—there has been some issues in this area
- Department is down about 25%—however there are 4 officers in training
- Entering in agreement with transit that will send a couple/few officers in that direction
- Recently, 4 officers have completed drone training—helpful for search and rescue (ie infrared on Elk Rock Island)—has to be an emergency safety issue or crime has been committed
- Been a Busy Month for Department—several officers are about to begin wearing body cams (still working out the admin details)
- In the process of bringing on an embedded mental health worker—while officers are well trained in CIT (crisis intervention technique) and deescalation, having someone who is not a cop can be helpful as well
- We are looking for our own worker that can follow our officers in Milwaukie
- Department responds to somewhere between 300-500 mental health calls a year

### C. NDA Concerns PSAC Members

- Island station— Ways to slow traffic on River Road (was emailed to committee)—Hoping that the city will work with Island Station to work on the traffic control options.
- Lewelling—Biggest issues currently have to deal with a safe routes to school study around Lewelling elementary
  - Preparations are being made for CareFree Sunday and Ball-Michelle Park
- Adenwald—29th Ave greenway —there are some safety measures (Sharrows)that have been in the TSP since 2013 for improvements on the 29th Ave Greenway. Hoping PSAC will be more active to voice concerns to City Council attend to this issue
  - on 29th someone painted stop stripes. City Manager says sharrows are being lined up for 29th but supply issues holding up. What kind of time line are we looking at for the sharrow?
  - A traffic Study needs to be conducted likely starting in September.
  - There is a hole about 1 foot deep on the Spring Water Trail on western edge of 3-bridges project over McLoughlin Blvd. PBOT was contacted about this and PBot says referring to its Parks and Maintenance Department.
  - Bikes are required to stop at a light but not at a stop sign unless its an E-bike which is considered a vehicle.
- Linwood—currently interested in PSAC LandUse acknowledgment
- Historic Milwaukie—Campers have been showing up as a concern
- Hector Cambell—No current concerns

### D. Capital Improvement Plan Projects Steve Adams

- 43d and 42nd mostly completed—hoping to be done in next couple months
- Lake rd is almost done
- Linwood is done
- Home and wood is causing along
- Ardenwald north is 60% design completed
- Monroe apartments—paving is expected in August
- Elk Rock Estates—construction is supposed to start this summer (all improvements are under 1 permit)
- Walnut addition on 33rd and Roswell—underground utilities are completed
- Burnum oaks off of Waverly CRt—still waiting to hear back about paving
- 8 lot subdivision at Home and Harrison planning to go in.
