## NOTICE OF PUBLIC HEARING

### Amendments to Milwaukie Zoning Ordinance and Comprehensive Plan

The **Milwaukie City Council** will hold a public hearing at **7:00 p.m. on Tuesday, May 5, 2015**, at Milwaukie City Hall, 10722 SE Main Street, to consider a recommendation for proposed Zoning and Comprehensive Plan text and map Amendments (File #CPA-14-02/ZA-14-02). This matter was previously heard by the Planning Commission at hearings on January 14, January 28, February 10, February 24, and March 10. At the March 10 hearing, the Planning Commission recommended approval of this application.

#### Summary of Proposed Changes

- Milwaukie Comprehensive Plan Chapter 4: Land Use - update to reflect proposed zoning map amendments
- Downtown and Riverfront Land Use Framework Plan (an ancillary document to the Comprehensive Plan) - update text and map to reflect revised land use concepts (to be implemented by zoning ordinance amendments)
- Zoning map - combine 4 downtown zones into one Downtown Mixed-Use zone; renaming the Downtown Open Space zone to Open Space zone
- Zoning Ordinance –
  - Section 19.304: Combine 4 mixed-use zones into one Downtown Mixed-Use zone; revise use, development, and design standards.
  - Chapter 19.500: New Section 19.508 Downtown Site and Building Design Standards. Expanded standards for use with a new Type II land use review process
  - Section 19.907: Establish a new Type II administrative review option for development that meets the revised downtown design standards – provides an alternative to the current Type III discretionary process

Testimony and comments at this hearing must be directed towards the criteria identified. If you submit a written comment or comment in person at the hearing, you will be sent a copy of the decision or recommendation. All written and verbal comments become part of the permanent record.

**Failure to raise an issue with sufficient specificity, and accompanied by statements or evidence sufficient to afford the responsible parties an opportunity to respond to the issue, will preclude any appeal on that issue to the Land Use Board of Appeals (LUBA).**
