## **Milwaukie Elections 2022 Linwood NDA Debate Plan**

### **Purpose:**

Provide Milwaukie voters with a debate and gathering for choosing their 2023 elected officials.

### **Objective:**

Hold a debate in middle to late October at Ledding Library and a meet and greet afterwards at Milwaukie Beer Store.

### **Plan:**

#### **Phase I – Mid September**

Develop a plan and course of action. Team leaders are Greg Hemer, Liz Start, and Zac Perry.

#### **Phase II – Early October**

##### **Information Committee**

Gather 30 people of Milwaukie voters to collect information, likes, dislikes, and questions about Milwaukie in general. The 30 people shall be held anonymous from candidates. Our expectation is to send 30 invites in total, but some may bring partners, children, or a friend. Non invited attendees are welcome as long as they are not currently in office or are running for an office position inside Clackamas and/or surrounding counties.

##### **Selection of Information Committee**

24 of the 30 Information Committee will be invited by the Team Leaders. 6 will be at large from each NDA (except Linwood), the NDA's inviting one to be a participant. The Information Committee will include a list of noninvolved, semi-involved, and involved voters with a variety of concerns. Diversity to the group shall include, but not limited to: race, sexual orientation, income levels, age, parents with a variety of age of children, small business owners, place of residents inside the City, and other such inclusions.

The Hemer Household will host the meeting in a friendly open environment. The meeting will not ask the Information Committee to discuss State or National politics, but allow participants to voice their opinions and concerns regarding the future of Milwaukie. The information gathered will be scribed and brought forth to the team leaders.

### **Phase III – Early to mid-October**

Team leaders using the information gathered during the Information Committee Meeting will formulate questions for use during the debate.

### **Phase IV – Mid to late October**

#### **Debate**

#### **Location**

We will hold the debate in front of a live audience, on Zoom (if regulations allow), and taped for public TV and posting on Milwaukie Heritage Channel and/or City of Milwaukie Channel (if regulations allow) on YouTube. The event is planned for Ledding Library, date to be determined based on candidate availability.

#### **Time Expectations**

2- 45-minute debates

2- 5-minute presentations

Total program length – 2 hours

Program begins at 5:30pm and concludes at 7:30pm

#### **Candidates**

##### **Unopposed**

We will allow candidates running unopposed 5 minutes before the debate to state their case for running for a particular Council Position. No questions will be asked.

##### **Opposed**

Those running against another candidate are scheduled for 45 minutes for total program time. The moderator will give each candidate 3 minutes to introduce themselves to the voters. The debate portion of the program will consist of a question being asked to a candidate with a 3-minute response. The opposing candidate will be given 3 minutes for a rebuttal or statement about their position of the question asked. Questions will continue on an alternating basis to each candidate. Our expectation is to ask 5 questions during the debate, but more or less may be asked depending on response times from each candidate. Each candidate at the conclusion of the debate, will be given 3 minutes for closing remarks.

Each position with opposition will have their own debate against their candidate. The second debate may or may not contain the same questions as asked in the prior debate.

## Information

Greg Hemer will be the moderator.

Candidate going first will be chosen by a coin flip at the beginning of the program.

Candidates will not be given the questions before hand, but will be contacted with the general categories the specific questions contain.

Council position will be held first, followed by the Mayoral race.

## Gathering

Immediately after the conclusion of the debate, Linwood NDA will host a “Meet Your Candidates” forum at Milwaukie Beer Store. This is an informal gathering to allow members of the public to ask one on one questions to each candidate. The gathering is not required by each candidate to attend, but is meant as an opportunity for the general public to clarify or ask a question that was not part of the debate.

Linwood NDA will not be purchasing any food or drink at the event for the general public, team leaders, or candidates. This is not an endorsement of any candidate, but should be viewed as an opportunity to gather after the debate.

## Time

The Gathering will officially begin at 8pm as advertised by Linwood NDA and will last for 1 hour. Candidates may stay or leave whenever they wish.

## General Information

### Advertising

Linwood NDA will create the advertising for the event. We will advertise in the Pilot and on the City Calendar (if regulations allow), inside Ledding Library, fliers around town, and Linwood NDA Facebook page. We will encourage all NDA's to help advertise the event and will create press releases for other interested organizations for announcements.

### Endorsement of Candidates

Linwood NDA does not endorse a single candidate. Team leaders and Information Committee members may have or in the future endorse a candidate in their personal capacity, but no bias or endorsement will be taking place during Information Committee Meeting, formulating questions, or debate. No candidate information will be presented during Information Committee Meeting including literature and signage. No Information Committee members will be chosen for their endorsement, relation, or knowledge of a candidate. The team leaders were chosen by Linwood NDA officers. The moderator was chosen by the team leaders.

### Information Collected

No information of diversity will be collected by the team leaders of the Information Committee. The team leaders have chosen the 24 based off their knowledge and are responsible for

maintaining the integrity of the debate purpose. Team leaders will be made public during the programming and will be general knowledge to all those participating.

After the program has concluded, Linwood NDA is happy to share the scribed information during the Information Committee meeting to the candidates, if they wish to have the information. Team leaders will consider this "public knowledge" after the program and is available to any one who requests it. No names will be attached to information provided and may be rewritten from its original format for ease of disbursement.
