We will ask Council to authorize us to sign the construction contract at the January 16 meeting. We expect to have a public construction kick off event which is tentatively scheduled for Balfour Park on Saturday, February 24 with more details to come. Construction will be substantially completed by October 11 barring significant delays. I don't know exactly when construction will begin but it will be relatively soon. Please note that the park and access to Where Else Lane will be closed during construction. Final Design Engagement: We are wrapping up a report on the Final Design Engagement which will be emailed out and presented at the January PARB meeting. We also adjusted the playground and safety surface colors slightly based on feedback."
