- 1) Land Survey of Southern Boundary of Spring Park Natural Area Eliminate encroachment of almost an acre that precludes public use (12% of Natural Area) Land survey completed November 2017
- 2) Milwaukie Bay Park Saving giant redwood tree recognized in 2017 as a goal in Phase III
- 3) Encourage City to adopt "Dark Skies" Initiative In City's 2017 Vision Statement
- 4) How to create a "Destination" within Milwaukie Draw visitors to City, which encourages new businesses, which creates demand for new office and shop space, which increases the property tax base from new buildings, which increases income for the City, which allows City to "do more" put on more events, do more road repair, etc. Funded Milwaukie Historical Society's Lot's Loop walk in 2017
