A. Proposed budget for utilities BN 2016-18

Gary provided information on the Transportation, Water, Wastewater and Stormwater Funds and the proposed budget for the upcoming biennium. Of note: the State Gas Tax Fund continues to have issues with being underfunded – one help is a proposal that street sweeping will be funded completely from the Stormwater Fund (moving from 50% to 100% funded).

The Water Fund is looking healthy; the Stormwater Fund has some large capital expenses coming as the master plan projects are constructed. The Wastewater Fund is doing well but the treatment cost is expected to rise significantly.
