CONSENT AGENDA

The February 3, 2016, meeting minutes were approved.

II. REPORT

A. Update on Utility budgets/CIP

The group discussed the wastewater, water and stormwater rates. The desire is to minimize financial impacts to residents while not jeopardizing the functioning of the utilities.

The group looked at spreadsheet approximations of the effects of rate changes on the utilities. After discussion the CUAB recommended by a 4-0 vote to leave the storm rate increase at 14.1%, lower the wastewater rate increase to 4%, and lower the water rate increase to 3.5%.

III. DISCUSSION

A. Update on Field Trip

First choice will be pipe replacement projects coordinating field visits with the Engineering team. There may be some opportunities to visit maintenance work such as well shaft replacement. These visits will be coordinated through Public Works.

IV. MATTERS FROM THE BOARD

Chuck Eaton provided information on the SSMP and how the program is nearing completion of its identified work scope. The CUAB voted 4-0 to recommend spending SSMP funds for the paving of residential streets. Chuck will include this recommendation in his annual SSMP report to Council.
