The Milwaukie Wellness Center is a home-based business currently in operation at the subject property. Recently, a second home-based business was added (Milwaukie Hardwoods). The applicant seeks relief from several restrictions of the city's home occupation standards: (1) to allow non-resident employees (up to 4) when there is more than 1 home-based business at a site, (2) to allow more than two home-based businesses at a site (up to 4 businesses total), and (3) to allow up to 2 non-resident business owners to operate at the site under the umbrella of an existing home-based business.
