## NOTICE OF PUBLIC HEARING Amendments to Milwaukie Municipal Code

The **Milwaukie Planning Commission** will hold a public hearing at 6:30 p.m. on **Tuesday, December 8, 2020** to consider a recommendation for proposed Municipal code text Amendments (File #ZA-2020-001).

### Summary of Proposed Changes

- Municipal Code –
  - MMC 11.05 Temporary Uses, Permits and Regulations
    - The proposed amendments relate to MMC 11.05 Temporary Uses, Permits and Regulations relating to permitting for temporary emergency housing. The proposed amendments add language that clearly states emergency temporary housing is an allowed temporary use. These changes provide needed clarification and will increase certainty and understanding of the process to create or establish emergency temporary housing facilities including allowing vehicle parking for housing for a short period of time.

Testimony and comments at this hearing must be directed towards the criteria identified. If you submit a written comment or comment in person at the hearing, you will be sent a copy of the decision or recommendation. All written and verbal comments become part of the permanent record.
