PROPOSAL:

ZONE: R-2/R-1-B

Request to modify a condition of approval from land use file #CSU-2017-007, which approved a major renovation of the Milwaukie High School campus. The condition in question required dedication of public right-of-way (ROW) at the east end of Adams Street for a future connection to 23rd Avenue on the campus. The proposed modification would require a public access easement instead of ROW dedication; although a future full-street improvement is unlikely, the City wishes to preserve the option for a future bicycle/pedestrian connection.
