The amendments were adopted by Milwaukie City Council as Ordinance #2226 on March 21, 2023. The ordinance amended several sections of the zoning code to update and reorganize the downtown design review process, including MMC Sections 19.304, 19.508, and 19.907, as well as Subsections 19.911.6 and 19.1004.3.
