

NOTICE OF PUBLIC HEARING Amendments to Milwaukie Municipal Code

The **Milwaukie Planning Commission** will hold a public hearing **at 6:30 p.m. on Tuesday**, **September 27, 2022** to consider a recommendation for proposed Municipal code text and map amendments (Primary File #ZA-2022-002).

The Planning Commission will hold this meeting both in person at City Hall and through Zoom video.

Summary of Proposed Changes

- Municipal Code multiple sections
 - The proposed code amendments relate to:
 - consolidation of the city's high density residential zones (R-3, R-2.5, R-2, R-1, and R-1-B) into three (3) zones: R-3, R-2, R-1-B
 - amendments to definitions of types of residential care facilities
 - amendments to terminology and definitions of boarding houses
 - streamlining of land use review processes for some uses in the high density zones
 - associated amendments in other code sections to ensure consistency across the code.

You may send written comments in advance to the staff contact listed below, or you may submit your comments in person at the hearing. If you want to present verbal testimony, either pro, con, or to raise questions, you will be invited to speak following the staff report presentation. Testimony and comments at this hearing must be directed towards the criteria identified. If you submit a written comment or comment in person at the hearing, you will be sent a copy of the decision or recommendation. All written and verbal comments become part of the permanent record.

Failure to raise an issue with sufficient specificity, and accompanied by statements or evidence sufficient to afford the responsible parties an opportunity to respond to the issue, will preclude any appeal on that issue to the Land Use Board of Appeals (LUBA).
