## NOTICE OF <u>RESCINDED</u> DECISION

Decision:	The initial Type II decision is rescinded and will be re-processed.

## **Explanation**

The proposal to divide the subject property to create four sublots using the middle housing land division process was erroneously reviewed as a Type II land use application instead of as an expedited land division as required by Oregon Revised Statutes (ORS) 92.031. A decision was initially issued on April 8, 2025, with the appeal period ending on April 23, 2025. After additional consideration of the applicable ORS, and prior to the decision becoming effective as per Milwaukie Municipal Code (MMC) Subsection 19.1001.7.D, the Planning Manager has determined that the proposal was improperly noticed and should be processed again using the appropriate procedures as outlined in ORS 197. 360 to 197.380 as directed by ORS 92.031. The initially issued decision is hereby formally rescinded, and the application will be re-processed with the required procedures established in ORS 197.360 to 197.380.
