Proposal:	<ul style="list-style-type: none"> - Bridge City Church wants to convert 3 pastoral offices to professional offices to be rented and used during normal work hours in a temporary capacity. - The applicant states the purpose of this proposal is part of their plan to return financial sustainability, but have no plans to be a property management company. They plan to only rent out these offices only for the short term to re-build the core of their church community. - The site is currently a religious institution that has a Community Service Use designation. They are in a R-2 zone as well. - The impact of this proposal is intended to have very low impact to the building and neighborhood. According to the applicant, normal traffic/parking flow will continue that has been exhibited for the past ten years.

If you want to present verbal testimony, either pro, con, or to raise questions, you will be invited to speak following the applicant’s testimony. Testimony and comments at this hearing must be directed towards the criteria identified. If you submit a written comment or comment in person at the hearing, you will be sent a copy of the decision or recommendation. All written and verbal comments become part of the permanent record.

The Neighborhood District Association, listed on the first page of this notice, may take a position on the proposal and may have scheduled an open meeting prior to providing comment to the Planning Commission. Please contact the person listed as the neighborhood contact to determine the time and date of this meeting.

To appeal a decision: Any decision may be appealed to City Council by a person with standing. In order to establish standing, you must do at least one of the following: submit written comments to the staff contact before the hearing date; attend the hearing and sign in; or attend the hearing, sign in, and make a verbal comment. Any issue that is intended to provide a basis for appeal must be raised in writing on or before the hearing date with sufficient specificity to afford the responsible parties an opportunity to respond to the issue. Failure to raise an issue with sufficient specificity, and accompanied by statements or evidence sufficient to afford the responsible parties an opportunity to respond to the issue, will preclude any appeal on that issue to the Land Use Board of Appeals (LUBA).
