
REVISION MEMO

As described in our memo dated September 26, 2018, MMC Subsection 19.402.11.D.2 requires planting 14 trees and 71 shrubs to mitigate for impacts to HCA resulting from the revised site plan. However, because the undisturbed HCA on the site is fully forested under existing conditions, there is little opportunity to plant additional trees on the site. Based on these existing site conditions, PHS's September 26 memo described planting fewer trees (10) and more shrubs (96) than the number required by code. In order to avoid a Type II review process, the City recommended changing the proposed mitigation planting to meet those required by MMC Subsection 19.402.11.D.2. Therefore, the mitigation plan has been revised. The number and species of trees and shrubs proposed for planting to compensate for impacts to the HCA are listed in the table below. The designated shrubs will be planted in areas of temporary disturbance, in areas where invasive species are removed, and in areas where understory vegetation is sparse under existing conditions. The designated trees will be planted, as shown on landscape planting plan provided by Place.






