II. Project or Program Details

Describe the goal and the need for the proposed project or program.

Given the lack of neighborhood concerts this summer, the Arts Committee has scheduled four porch concerts that will be broadcast on local access TV and streamed via the internet, while simultaneously encouraging anyone with music in their hearts to come outdoors and play or sing. This is expected to be the first annual Porchfest event in Milwaukie. It will take place on four successive Friday evenings in August and September.

Who will be involved in the project or program and how has support evolved in the neighborhood/s?

The Lewelling NDA has been extremely supportive, committing to pay up to \$2,500. However, the four featured performances will be in different parts of the City. For that reason other NDAs are being asked to contribute as a reimbursement to Lewelling. When the Porchfest idea was first tried on the entire Lewelling Neighborhood contact list (approx. 75 people), support for the idea was overwhelming.

Project Time Frame: Beginning Date 8/21/20 End Date 9/11/20

Please describe how the grant money, if approved, would be used:

Three of the featured performers have agreed to accept \$400 and one has agreed to \$300. Willamette Falls Studio will be providing a videographer for \$100 per night. That totals \$1,900. Additional funds will go for promotional materials. If enough money is provided by the NDAs, it may be possible to add another performance night in September, but the initial focus is on a fair reimbursement of the Lewelling NDA.
