- Phillip discusses the safe routes to school update for Lewelling Neighborhood

IV. Fire Report-Jack Tanz

- 2,700 calls in September
- Backyard burns are open for the month of November-Please be sure to be outside DEQ Proximity
- November is fire alarm awareness
- Keep portable heaters monitored in the home
- Monitor candles
- Keep cooking to the kitchen
- Smoke alarms should be on every level of the home as well as carbon monoxide alarms installed per the instructions on the package
- 49th annual operation Santa Clause will collect toys and food to distribute to the community
- No donations will be collected during the parade, it is strictly an information parade

V. Police Report-

- Clackamas county domestic sweep (roughly 200 agencies participate) go out an make a connected and concerted effort to apprehend abusers
- Saturday 10/28/23—craft with a cop at Milwaukie floral 11-3; there will also be a downtown trick or treat from 1-4
- Officer Morton Cleary and atom graduated academy on training. Cleary was top academic student and asked to give class speech

- Extra cops are currently new recruits in training
- 12/4/23— Swearing in Robbie Nashif. Kaiser PD from 95'-98'. Then CCSO and 189 years traffic team. Top ticket writer in the county in the last 5-7 years.
- Shop with a cop in December (10 kids will be sponsored)—looking for kids who are low income; could be houseless; could have experienced recent tragedy; could have lost recent parent due to jail or other traumatic complication. Kids will typically be K-6th grade age, but we have made exceptions.
- Hoping to bring back the canine tracking program in the next 12-18 months—officers are currently undergoing training
- Officer Dormon recently hired from Dallas
- Measure 114 is currently not enforced—currently Status quo is that gun laws have not changed due to litigation
- Photo Radar enforcement has to be approved by the city council

VI. Capital Improvement Projects-Jen G.

- Washington area pre con start—December
- Sidewalk to connect public works on Johnson creek
- New project is the ADA Ramp project coming out. Various location throughout the city will add 29 new compliant ramps—Milwaukie received a grant from Clackamas county
- Hope to go to council by 11/7 to award this
- Public comments period after thanksgiving, and will go to council in January to be adopted and approved
- 11/2—King road project on first floor in community room (5-7 pm)
- Awaiting notice to proceed from ODOT for Monroe Greenway

VII. King and 42nd Street -Jeff Tolentino

- Primary aim for this project to improve safe for all users for the intersection, including drivers, bicyclist, and pedestrian.
- Former intersection concerns—Uncontrolled left hand turn in the westbound direction from king.
- Uncontrolled left hand turn in the northbound direction from 42nd
- Temporary Measures
- Tuff Curb and tubular delineators
- Eliminated left hand turn in the northbound direction from 42nd
- Eliminated East round movement through intersection along g king
- Preserves uncontrolled left hand turn in rebound direction from King to maintain arterial flow
- Permanent Design— Alternatives for a permanent design are being considered for the upcoming logos, m 40th and 42nd CIP project

—If public would like to see art please submit a comment to council to see if this might be an option for the city

- This project is separate from the King Road Project.

VIII. NDA Concerns

-Lewelling- Concerned about potential 61 units at 42nd and Johnson Creek Road—

- If there are an increased number of vehicles on Johnson Creek, how will the city respond
 - Might be some additional funding from the city for the Safe routes to school project
- Ardenwald—also concerned about the 42nd and Johnson Creek area; property owner on NW corner is concerned that the development will severely impair her ability to get into her property
- Hector Campbell—No update to report
- Island Station—area of concern has been addressed by the railroad
- Lake Road— Milwaukie Floral is very interested in becoming a Hub, and driven by the owners of Milwaukie Floral.
- Linwood—real concern about how tangible or real the Community Hubs project is/was. What are the goals? What steps are we in and what is the next step?

IX. TSP update

- Varried age and gender were represented
- Meeting was a starting meeting. There will be 8 advisory meetings over the next two years
- There will also be a technical advisory meeting that is not open to the public
- Each neighborhood has a representative showing a broad approach
- CFES—Climate Friendly Equitable Community
- Stanley needs to be addresses as a more multi-use road with considerations in that way.
