Furnberg Park: Adam reviewed the Shelter Legacy Project history. The Linwood NDA has paused the project until its September meeting.

Balfour Park: A 3rd party safety audit determined that the basalt columns are considered playground equipment and must meet safety standards, including a 6-foot clearance. This is a different interpretation of the rules than taken by the project team. Rocks at the park are closed what the two different safety reviewers and City determine the proper course of action.
