**Introduction**


**Police report (Bob Jordan, Milwaukie Police Chief)**

Burglaries and arrests have been up since Christmas. A crime stat map was handed out. Officer of the Year dinner is March 21, 2012. If you see anything suspicious, call the non-emergency at 503-786-7500. If you see a crime in progress, call 9-1-1. The crime map is accessible on Milwaukie's website and Ardenwald.org.

**Good Neighbor Agreement with Precision Castparts (John Reichlein, Brentwood-Darlington NDA co-chair)**

John is introducing a Good Neighbor Agreement (GNA) with the Precision Castparts. Last May there was a HAZMAT incident that affected both Brentwood-Darlington and Ardenwald neighborhoods. He handed out some documents and news articles (he also requested to be returned after finished reading). He mentioned a website "Smoke Stack Effect" article in USA Today.

There are other businesses emitting pollution along SE Johnson Cr. Blvd., such as the styrofoam plant. Matt Rinker asked if Lewelling NDA has been contacted because they are neighboring the plants. The Public Safety Advisory Committee (PSAC) representative is out tonight. Matt said the NDA cannot agree to the GNA right now until we know what it is in the GNA. Marianne Colgrove said we should get an interest to the GNA. Lisa Gunion-Rinker says there is more benefit having more NDA sign on.

Matt Rinker suggests that we can gather more information and have a letter before the Ardenwald NDA may endorse it. John also provided a petition for those interested in signing. Jeff Davis said that a GNA also establishes communication. Jeff said he also lives near the plant for the past 20 years and reports he hasn't had any issues. Matt said the next step is to get other NDA.

**Neighborhood Main Street Project (Jay Higgins and Tony Vi)**

Jay and Tony thanked those who participated in the walking tour last Saturday (March 10). The next "big" public meeting is next Wednesday (March 21, 2012, Seth Lewelling Elementary School , 6 p.m. to 8 p.m.). There is an online survey at Milwaukie's website. The project affects S.E. 32<sup>nd</sup> Ave. between S.E. Floss St. and near S.E. Olsen St. The city won't support ideas that the neighborhoods won't support. The areas are already zoned for commercial. This does not include S.E. Harrison between S.E. Lewellyn and S.E. Harrison St. The other area is S.E. 42<sup>nd</sup> Ave. near King Rd. A representative from Milwaukie Rules was on the tour. They also provided a brief background on the project.

**Law Enforcement Competition (Matt Rinker)**

A discussion was held regarding contributing to Law Enforcement Competition. A comment was made about NDA account balance since the Treasurer has been away. No comments of opposition was made.

**MOTION: GRANT \$200 FOR LAW ENFORCEMENT COMPETITION.** Matt Rinker moves, Sonja Souder seconds. **Motion passes unanimously.**


**Milwaukie High School Graduation Night Grant Discussion**

A discussion was held to use the remaining educational purpose funds from the Walk Safely Milwaukie Program (about \$190, exact amount figure was not provided) for Milwaukie Police Bike Refurbishing Program. No comment of opposition was made.

**Committee Report**

Matt talked about the Milwaukie Baseball Stadium Project and the Good Neighbor Agreement discussion.

Jeff Davis talked about the Summer Concerts. There are five concerts this year because of five Thursdays. He announced some of the bands: 1. Get Rythmn (Aug. 2) . 2. Louis Payne with LaRhonda Steele (Aug. 9). 3. Fraco Palenta and the Stingers (Aug. 16). 4. SloeGinFizz (Aug. 23). Fifth concert (Aug. 30) is still open. Expense is higher because sound cost is up and there are five events this year. The cost is about \$300-400 per event. We could do some fund raising and ask for donations.

Matt read an email from a group that does home energy efficiency upgrades. Matt handed out a flyer.

A representative of Milwaukie High School Dance Team presented a framed thank you note with picture for the NDA's support of the dance team.

Lisa Gunion Rinker talked about a plant sale to raise funds for the Balfour St. Park and a chicken coop tour. Milwaukie still has a 50-chicken limit. Also, garden tour if we can get people to participate. Hillside has 20 gardens and planning on adding 10 more. Providence is also build a community garden, but this is tentative. Lisa decided not to do an official plant sale this year. There was no objection from members.

Bryan updated on the Southeast Uplift Communications Meetings. He is also writing the April 2012 Milwaukie Pilot. April 2012 The Pilot will be online edition only, but have to put emphasis on May board elections on May 8, 2012. He also said special projects like Neighborhood Main Street Program and Milwaukie Baseball Stadium projects have special resource pages at [www.ardenwald.org](http://www.ardenwald.org).


