III. Bylaws discussion

- a. Stephan walked through his proposed edits, all approved:

 - Article IV.C.2 add “when requested by City Council to do so”
 - Article IV.E replace “6” with “more than half” and add “as then constituted”
 - Article IV.F Meeting Procedures added that were voted on and approved from last meeting
 - Article IV.G Agenda Order
 - o Added mission statement and land acknowledgement statement
 - o Add Clackamas Fire Report, Police Report and relist order of reports given
 - o Move Public Comments before the reports in agenda, provide time limit
 - Article IV.H Changing from “However” to Unless” and replace “may be” with “is”
 - Article V.D.3 Replace “design review” with committee” and remove “application or”

Stephan asks which firm is working on redesign of 42nd and King. Kittelson is designing King Road.

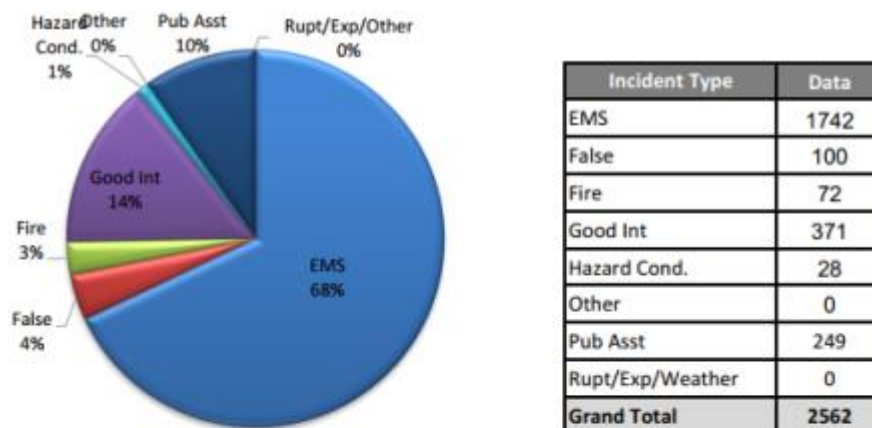
ODOT gave the go ahead to TSP on 5/24/23. Laura and Steve to get with Kittelson to set up schedule of meetings.

CFD June 2023 PSAC notes

- During the month of May, the Fire District had a total monthly call volume of 2,562. This continues to demonstrate an increase in year to date when comparing to previous years. At the ½ way mark for the calendar year, there are over 1000 more incidents than this time last year. All types of incidents are seeing an increase but the primary area is EMS calls.

- A big thank you to the communities we serve for their support of the Emergency Services Levy. The Fire District is excited to continue improving and providing the highest level of service to our communities. Here are a couple updates for progress related to the levy:
 - Increase total staffing by 62 firefighters over the life of the levy.
 - Year 1 Objectives:
 - Hire 24 firefighters
 - Increase staffing at 5 community fire stations to be announced
 - 24/7 career staffing at Clarkes Fire Station
- On July 1, Clackamas Fire begins providing a full contract for service to Sandy Fire District. Due to the success of the partial contract over the past several years, both agencies' Boards of Directors agreed to move all of Sandy Fire services to a full contract with Clackamas Fire.
- Backyard burning is officially closed until the fall.
- Be aware of increasing fire danger levels as we enter summer and see continued dry weather.
- This month the Fire District safety focus is on grilling/BBQ safety, firework safety, and defensible space:
 - Grilling/BBQ Safety: Only use them outside, keep well away from combustibles, keep clean of grease and fat build up, and never leave unattended.

- Firework safety: Fireworks will go on sale in late June. Only use legal fireworks and encourage safe practices when using them (don't hold, distance from combustibles, etc.). "Be prepared, be responsible, be safe, and be aware". There are numerous commercial fireworks displays around the Fire District that are a great alternative to doing your own. (only use for the first part of July)
- Defensible Space: Encourage defensible space from homes for wildfire protection and prevention. Keep larger trees and shrubs away from the home, keep grasses/brush cut low, and check your roof for combustible building of debris.
