III. Reports

**Clackamas Fire District Report**

Sept 2400 calls slightly more than previous years , mostly EMS calls

20k calls year to date- on track to reach 30k calls for the year

Cooking PSA: never leave food unattended, keep kids and pets away from cooking, and NEVER throw water on a grease fire

Clackamas Fire District Levy discussion, all meetings 6-7:30

Nov 9<sup>th</sup> at Beaver Creek Station 10

Nov 16<sup>th</sup> at Pleasant Valley Station 7

Jan 4<sup>th</sup> at John Adams Station 15

Can be attended via zoom as well

The levy will discuss staffing, wildfires, and alternative response

If the levy is approved by the Fire District Board it could be referred to voters in May 2023

DEQ lifted burn ban but still call to see if burning is allowed for that day

## **Milwaukie Police Department Report**

### Oct 26<sup>th</sup> -incident at HS

Call to MPD around 11:49 a report of an individual wearing dark clothing, facemask, and carrying a rifle. The report was assessed as credible—lockdown was initiated

11:53 officers arrived on scene, they identified the student was not armed- it was an umbrella, not a rifle. There were teams in the building within minutes, went through precautionary clearing of building. Police and staff wanted a complete search of the premises. The officers remained at school to speak with staff, parents and students after the search was completed.

*Christina: how do you feel your squad performed, what is your assessment? Did they evacuate?*

Officer Graves feels his response time was good and overall it went well. Milwaukie HS had lights out, doors locked, they were taking cover; the systems and protocols that had been practiced were executed well by students and staff.

*Steve: how many officers were involved?*

Officer Graves: we had 8 officers, identified the person of interest right away so did not call in more officers

### Oct 25<sup>th</sup> -2<sup>nd</sup> Drone capture

Suspect for domestic abuse and strangulation charges

Got a drone and canine unit on the suspect

It was easy to get officers with the drone and got into custody. It makes it safer for officers

*Question : brand of drones? DGI*

All of our officers have body-worn cameras now. The average officer produces a Gig of data per shift. We have automatic retention schedules; if it gets tagged and saved- 2 years, accidental recordings are saved- 14 days, traffic and misdemeanor- 5 years, felony crimes - 10years, critical incident (officer involved shooting, homicide, etc) indefinitely

*Elvis question: is the photo radar being used to issue traffic citations?*

Officer Graves: No, those are used for speed control.

*Question: Does Halloween present any problem being short staffed at the moment?*

Officer Graves: we have to restrict time off during that day. The call volume really depends on the year and what day of the week it falls on.

## **NDA Concerns**

Ardenwald (Elvis Clark)- 2 neighbors believe the neighbor who lives between them is burning trash in their fireplace. There may be mental health issues involved. recommendation: Fire dept. may be helpful in connecting with neighbor and making an inquiry

Hector Campbell (Jessica)- nothing to report

Lake Road (Christine)- *Jay: any additional bike traffic since the construction has been completed?* Yes, there is definitely an increase.

Linwood (Christina)- She has been hearing good feedback about Linwood Ave

### **Report from Steve Adams**

Linwood Elementary-Steve met with the principal of Linwood Elementary and discussed the problem on Linwood Ave of the back-up of cars waiting to drop-off and pick-up their kids. They discussed a new system to be implemented in January that will hopefully alleviate some of the problem.

Lewelling

Seth Lewelyn Elementary - Safe Routes to School

Alta is the planning consultant. They are a nationwide firm and are experienced in multi-use paths and accessibility. We are in data collection mode right now...we got a traffic crash history on Stanley, King, and Monroe. That info with traffic count data will be given to Alta to make their recommendations. The next meeting is in December.

### **Capital Improvement Plan Projects**

- Wood Ave is pretty much done- all driveways complete, striping down, expect to be done by mid Nov
- Home is pouring sidewalk when they can, walking the site once per week, making adjustments to the project. There is a missing panel just south on entry to filling water meter with gravel.
- 42<sup>nd</sup> and 43<sup>rd</sup> opening party went well
- Ardenwald North Project: street upgrades and new pipes being put in
- Washington area 27<sup>th</sup> to 35<sup>th</sup>: bid and constructed next summer
- Roswell and 33<sup>rd</sup>-- adding 5 homes
- Apt on Lava & waverly- 32 units
- Long term Henley place- (Milwaukie Bowl location)- under construction til 2024

*Does Milwaukie salt or sand streets in icy condition?*

Public works has several vehicles that are equipped for managing snow, they focus on main streets- they do salt the sidewalks around public buildings.

Additional discussion on the origin of Safe Routes to School, ways to further encourage walking and biking to school, and the role PSAC plays in supporting that shift in public consciousness

V. TSP Discussion

Concerns brought up from a post on Bike Milwaukie's FB page:

How much participation do we have in TSP? How can we be active in the process and contribute ideas that we see show up in the end product? Does it feel at times like there is minimal impact from our involvement?

Christine- aren't we building off the 2007TSP? Since many of the projects were not completed many of those will be carried over into the updated plan and subsequently there will be less to decide on

Steve: there are federal and state mandates that legally need to be included in TSP. The numbers of participants in the meeting are kept at a number where we can hear ideas but are able to efficiently move the process forward.

~~Stephan Stephen~~ - there is a lot more participation in this community than in others where I have lived. Community impact on these issues is weakened by the large scope of technical material and length of projects – people get worn out. Leadership Academy is taking applications currently.

#### PSAC Representative Discussion

- 2 PSAC Representatives on the TSP committee
- Pending city approval, however Steve thinks it is likely to be approved
- The 3 committee members interested are: Elvis Clark, Christine G, and Pamela
- Jay will connect with Pamela about being TSP rep and confirm her continued interest since she is not present at today's meeting

David Aschenbrenner: no questions or comments, wanting to observe meeting to get up to date on current topics

- Since there is no meeting in November we have decided to elect our representatives over email
- Jay will connect with us all for via email for our vote on the 2 members we would like to have on the TSP committee
- Many members agreed it would be wise to activate our NDAs awareness around TSP by getting on the agenda at meetings (if not already), inviting neighbors to come with transportation concerns and improvement ideas

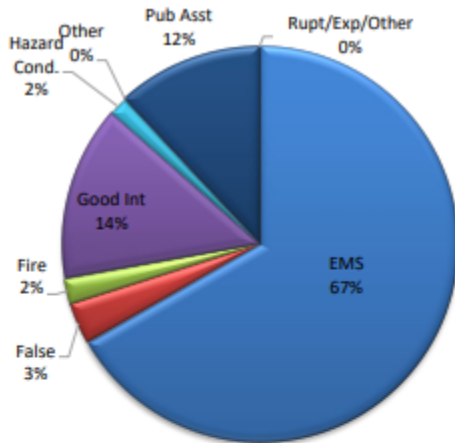

## Milwaukie Public Safety Advisory Committee notes

- My apologies for presenting October graphs, but the November ones won't come out until after the first of the month. During the month of October, the Fire District received 2,477 calls for service. This continues to be slightly more than previous years for this month but we are still trending slightly under last year for total projected calls for the year. As noted last month, the increase in incidents from previous years is primarily due to a higher number of EMS calls.

- For December, the Fire District's safety message is related to holiday safety. Remember to:
  - Make sure your tree is watered and hydrated. Keep it a safe distance from ignition sources.
  - Remove the tree from your house when it gets dry.
  - If you decide to burn candles, keep them a safe distance from anything combustible and be sure to not leave them unattended.
  - Be extremely careful with space heaters. At least three feet of clearance is recommended.
  - Be sure to not leave your stovetop cooking unattended.
  - Be sure to test your smoke alarms.

- o This will include four parades that unlike in years past will not pickup donations on the route, and five static drop off events that will be accepting donations.
